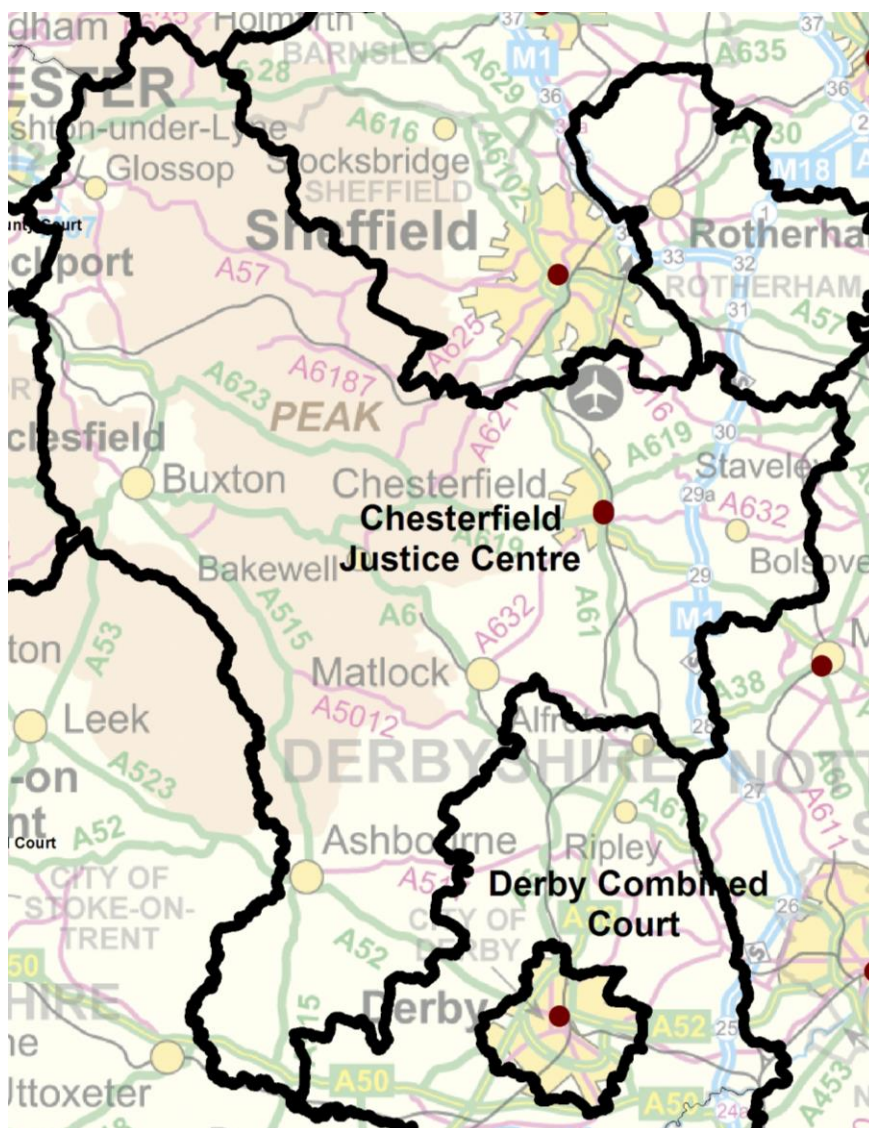
Housing Possession Court Duty Scheme Area: City of Derby and North Derbyshire
