“I respectfully request the Ministry of Defence supply me with the following information:

- **The total number of officers (inclusive of student officers) who have occupied a MDP HQ post on permanent terms since 1st January 2017**
- **The total number of officers currently undergoing student officer training who will occupy MDP HQ post on permanent terms before the end of this year**
- **The starting salary and spinal point for all student officers who have filled a MDP HQ post since 1ST January 2017**
- **The starting salary and spinal point of all student officers currently in training, who will occupying a MDP HQ post when their training is complete”**

A search for information has now been completed by the Ministry of Defence Police and I can confirm that some information in scope of your request is held.

- **The total number of officers (inclusive of student officers) who have occupied a MDP HQ post on permanent terms since 1st January 2017**

One Officer had been offered a position on temporary transfer terms, which subsequently changed to permanent terms.

- **The total number of officers currently undergoing student officer training who will occupy MDP HQ post on permanent terms before the end of this year**

There are currently no officers undergoing student training, however of the new intake of recruits in September none will be occupying a HQ position

- **The starting salary and spinal point for all student officers who have filled a MDP HQ post since 1st January 2017.**
