[Redacted] Nice and simple!

The MMSI numbers for 3 of the vessels are mentioned in the attachments of one of the cases. An MMSI number is an identification tag that's in the public domain and reports vessel location over radio (much like AIS but different applications), and a simple Google search of the MMSI number will give you a number of services that will tell you where the vessel was when it last reported, as well as related information. IMO numbers are also good if you can find them, but Google is all-powerful either way. It's always worth noting that the accuracy of information like this can be pretty poor but it's a useful first check.

As for MCA contacts, I have no idea! I could certainly link you up with the guy who deals with PMSCs/Maritime Security from DfT, as he works very closely with the MCA, but other than that not sure. Also asked Chris and he hasn't dealt with the MCA as part of his work.

"MV Horten was detained by inspectors from the Maritime and Coastguard Agency on 12 March 2014, following her arrival in the UK as an unregistered ship.

"At that time statutory surveys were found not to have been conducted or were expired, and the required certificates demonstrating compliance with all relevant Merchant Shipping Act regulations were not in force. Qualifications of seafarers on board did not meet mandatory requirements and the owner and master had not ensured that the ship conforms in all respects to relevant statutory provisions.

"Certification is linked to the ship's ability to demonstrate its compliance with a raft of regulations which require a minimum standard in terms of: hull and machinery condition, construction standard, safety equipment, radio equipment, Loadline, safe manning, safety management, security, and pollution prevention.

"The ship and its operators are expected to meet all national and international requirements applicable to them in respect of a seagoing vessel of that size and type. As mentioned in my last email on 08 September 2014, ship staff had requested release of the above ship to proceed to Nigeria.

In progress of this matter however it has been observed since that ship's statutory certification is still not in order, [Redacted]. There are a number of significant anomilies which is preventing verification of the apparent commercial organisations that have issued 'temporary' statutory certificates on behalf of the new registered flag state, the 'Togolise Republic'[Redacted].

We have been unable to verify anything through the normal published channels, or the French embassy (whom we understand act on behalf of Togo in the UK). I would like to ask if the desk at FCO that deals directly with the Togolise Republic could possibly assist with the verification of this matter? There appear to be two particular organisations issuing 'statutory certificates' for which we cannot formally verify their authorisation from the flag state (Togo) to do so, as follows:

(i) International Ship Registry

(ii) International Registrations Bureau

These organisations may however be one and the same. Interestingly International Registration Bureau appears to be based in the Lebanon from the +961 country code on their emails. There is also a 3rd organisation (Columbus American Register) where we have been able to establish partial authorisation for issuance of some certificates. We would like to request from the Togolise Republic confirmation of which organisations are authoroised to issue statutory certificates to their ships on their behalf.

As I said from an FCO perspective our primary concern is that military grade equipment, including vehicles and ships go through the correct export procedures before they are allowed to go to the end user. This process is led by BIS and through the FCO's Arms Export Policy Department coordinated with the country desk (in this case Nigeria) and where appropriate signed off by a Minister. [Redacted]

While the vessel is in UK territory, we have no real power/interest to act beyond what we have done so far [Redacted]. We could raise it with the Nigerian High Commission and or the Ministry of Defence in Nigeria if it continues to cause problems in the UK, but I think we would want to wait and see what reaction you get from the planned action you describe.

So I think from an FCO perspective we welcome this action and will take further interest if and when an export license requested is submitted.
