Thank you for your correspondence dated 7 June 2017 requesting the following information on:

'Could you please provide the figures for bounty waivers requests made to the Commander Maritime Reserves (CMR) from members of the Royal Marines Reserves (RMR) and the Royal Naval Reserves (RNR) from the period 1 April 2012 - 9 May 2017?

In addition could these figures be broken down into the following:

Waiver requests from individual Services (RMR and RNR)?
Waiver requests from individual units?
Waiver requests that were supported from the individual units?
Waiver requests that were rejected by CMR?
And, if feasible, the reasons for the rejections over the said period?'

Refined to:

'Yes, I would like the information for this years bounty waivers for the training year 2016-17.

But as I am trying to ascertain a link in the waiver requests et al, could I request the information (as detailed in the original request) for the years 2015-16 also please?'

Your enquiry has been considered to be a request for information in accordance with the Freedom of Information Act 2000.

I can confirm that the Ministry of Defence holds the information within the scope of the request and it is attached at Annex A to this letter.

For your information in line with the Office for National Statistics guidelines all totals are rounded as a means to prevent the unintentional disclosure of an individual's identity, therefore totals may not equal the sum of their parts. All numbers are rounded to the nearest 10 with numbers ending in 5 rounded to the nearest multiple of 20 to avoid bias. Numbers that would be rounded to 0 are represented by '~'. You should also note that '-' denotes zero.

If you are not satisfied with this response or you wish to complain about any aspect of the handling of your request, then you should contact me in the first instance. If informal resolution is not possible and you are still dissatisfied then you may apply for an independent internal review by contacting the Information Rights Compliance Team, Ground Floor, Zone D, MOD Main Building, Whitehall, SW1A 2HB (e-mail CIO-FOI-IR@mod.uk). Please note that any request for an internal review must be made within 40 working days of the date on which the attempt to reach informal resolution has come to an end.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
