FREEDOM OF INFORMATION ACT 2000: MINISTRY OF DEFENCE POLICE: Police Numbers

We refer to your email dated 2 May 2017, which was acknowledged on the 3 May 2017.

We are treating your email as a request for information in accordance with the Freedom of Information Act 2000 (FOIA 2000).

In your email you requested the following information:

- "Q1. How many officers do you employ (By rank, FTE and what department they are attached to how you record the information)
- Q2. How many Civilians do you employ (By name of role, FTE and what department they are attached to, how you record the information)
- Q3. How many PCSO's do you employ (By FTE, and what department they are attached to)"

A search for information has now been completed and I can confirm that some information within the scope of your request is held.

Please see the response at Annex A. These figures are accurate as at 31st March 2017.

Please note the Ministry of Defence Police do not have PCSOs.

If you are not satisfied with this response or wish to complain about any aspect of the handling of your request, then you should contact me in the first instance. If informal resolution is not possible and you are still dissatisfied then you may apply for an independent internal review by contacting the Information Rights Compliance team, Ground Floor Zone D, MOD Main Building, Whitehall, London SW1A 2HB (email CIO-FOI-IR@mod.uk). Please note that any request for an internal review must be made within 40 working days of the date on which the attempt to reach informal resolution has come to an end.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not investigate the case until the MOD internal review process has been completed.
