- *The (A585) Trunk Road (Windy Harbour Junction Improvements) Compulsory Purchase Order (No._) 201_ Advertised in the Blackpool Evening Gazette 24/06/2014*
- *The (M6) Motorway (Junction 17 Improvements, Private Means of Access to Local Highways) Side Roads Order 201_ Advertised in The London Gazette 13/02/2015*
