Thank you for your email of 30 November 2017 requesting the following information:

"During tax year 2016/17; how many medical officers were paid on the accredited consultants (OF3-OF5) payscale. Please can you list by pay increment held at end of year.

How many officers paid from that pay scale were notified by Veterans UK that they had incurred a charge in relation to pension inputs in excess of the annual pension allowance for tax year 2016/17".

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence and I can confirm that all the information in scope of your request is held.

During the tax year 2016/17 there were 437 medical officers paid on the accredited consultants (OF3-OF5) pay scale. A breakdown by increment at the end of the year can be found on the attached appendix.

Of those 437 listed, 91 incurred an Annual Allowance charge in relation to pension inputs in excess of the annual pension allowance for tax year 2016/17.
