FOI 754, 663 REQUEST FOR INFORMATION RELATING TO THE SUCCESSFUL TENDER OF THE CCS COURIER SERVICES FRAMEWORK RM3798

I am writing to advise you that we do hold information that is relevant to your request for information relating to the successful tender of the CCS Courier Services Framework RM3798 but regret to inform you of my decision not to disclose this information.

The information you requested is being withheld in reliance on the exemption in section 43 (2) [http://www.legislation.gov.uk/ukpga/2000/36/section/43] of the Freedom of Information Act 2000 because the award is currently in a stand still period and time needs to be allowed for the bidder to consider the offer and for any challenges to be made.

For information, once the standstill period ends and the contract is awarded the information will be made public via the Government's Contracts Finder page in compliance with transparency requirements.

In applying this exemption we have had to balance the public interest in withholding the information against the public interest in disclosure. The key public interest factors for and against disclosure are detailed in Annex A below.

If you are unhappy with the way we have handled your request you may ask for an internal review within 2 months of the date of this response for Freedom of Information requests and within 40 days for Environmental Information Regulations requests. Our internal review process is available at:

It is important to maintain the confidence of our suppliers in order to achieve best value for the tax payer; The award is currently in a stand still period to allow time for the bidder to consider the offer and for any challenges to be made. | | | | |
