Leveraging AI, IoT & Big Data analytics for the Future of India and UK

From self-driving cars to cat facial recognition swathes of human endeavour are being taken over by machines working faster, harder and more efficiently than humans. Will Artificial Intelligence dominate the tech landscape? The skills required for IoT implementation are those that Indian IT services companies have in abundance. But they need to be able to make bold moves and seize opportunities in the space. The Indian government has shown focus on increasing tax base & tackling black money through policy interventions like demonetisation, GST roll out, tax agreements, etc.
