Sudan, UK Keen to Upgrade Political, Economical and Humanitarian Ties. (Sudan vision, Almeghar Alsyasy Front page)

- Sudan and the United Kingdom on Tuesday reiterated their willingness to enhance their bilateral ties in political, economic and commercial fields.
- Official Sudanese-British talks were held in Khartoum Tuesday, co-chaired by Sudanese Foreign Ministry's Under Secretary Abdul-Ghani Al-Naeem and Permanent Under-Secretary at the British Foreign and Commonwealth Office, Sir Simon McDonald.
 "This visit of the British official reflects the level of development in the relationship between the two countries," Al-Naeem told reporters following the talks.
- We have discussed all issues, where on bilateral field we have reiterated the two countries' willingness to enhance their relations in the different fields," he added
- He said "at the regional level, we have discussed the issue of South Sudan and the necessity to achieve peace there, while at the international level, we discussed the issue of human trafficking McDonald, for his part, said that "we were able to discuss international, regional and bilateral issues, and have productive discussions in all these areas."
- The Ministry of International Cooperation has also held bilateral talks in which they discussed issues of mutual concern with the UK delegation along with method of extending humanitarian assistance to Sudan .
- The Under-Secretary of the British Foreign and Commonwealth Office, Sir Simon McDonald. Said Sudan demanded supporting its relations with the international economic organizations and he expressed his delight over visiting Sudan expressing readiness for extending the required support in all spheres so that Sudan may reach a lasting peace.
- Simon described the talks which discussed the challenges facing the humanitarian work and lay down long-term economic programs as "excellent "
- "The United Kingdom and Sudan have historic relations and we are building on those his7toricrel "The United Kingdom and Sudan have historic relations and we are building on those historic relations," he noted.
- The United Kingdom has affirmed that it will enhance Sudan's relations with all international economic institutions for lifting the economic blockade imposed on Sudan and tackling Sudan's debts file.

• For his part the Minister of International Cooperation, Osman wash has affirmed that the meeting has touched on many aspects including Britain's contribution in Sudan's debts as Britain has a big role in this sphere.

In Khartoum/ Darfur, you should wear long clothing (trousers/ skirt down to your feet, and sleeves minimum three quarter length). It's "winter" so won't be blazing hot, but will still seem warm to you! So I suggest light fabrics (cotton/ linen) and then bringing a scarf for if you get chilly either in the evening or under air conditioning. Recommend comfy flat shoes for footware – you'll be walking a lot on dusty and unstable ground, and on your feet in Darfur.

For work meetings a jacket is the norm as elsewhere.

I normally wear regular work trousers (either linen or normal) with a cotton shirt, and bring a work jacket/ shawl to take on and off as needed.

We haven't yet had on opportunity to raise this with GoS. We should definitely put it on the PUS' agenda as it demonstrates (i) ongoing instability in Darfur, **[REDACT SECTION 27]** (2) facts are still emerging and are disputed; and (3) there are questions about the role of UNAMID.

Please see attached the report from **[REDACT SECTION 40]** based on media and personal contacts, who put the death toll at 14 with 47 injured. This is similar to what is being reported in some media (9 dead, 60 injured according to <u>Sudan Tribune</u>) and fanned by advocacy groups who are terming it a massacre.

However the latest from UNAMID is that 2 people were killed by security forces and 26 injured (4 of whom were policemen). This chimes with the <u>Wali's comments</u> today that 28 people were wounded, including 4 policemen and 19 women.

UNAMID have picked up reports that while the main incident was underway in the Habat area, there were reports of GoS forces attacking the Straha area. However no victims have been confirmed.

I requested a report from UNAMID today which is copied below. The situation around Nertiti is described as "calm" thanks to intervention of the Deputy Wali, and UNAMID patrols have been stepped up. The Defence Minister and senior NISS officials are due in Zalingei tomorrow.

Recommendation

- We should tweet our concern. Since the numbers are disputed we should say something along the lines of: Concerned by reported violence in #Nertiti central #Darfur. Urge Govt of #Sudan to calm situation, investigate & and allow full access to #UNAMID. Since Michael is currently away, would you like to do this from the Sudan Unit account then we'll retweet?
- We should raise it with GoS and UNAMID during the PUS visit
- We'll continue to monitor developments closely including liaising daily with UNAMID and local contacts to establish facts.

UNAMID update: 03 January

The situation in Nertiti is assessed as calm. No major development/incident was reported today.

The following action points were decided:

- 1. Continuous monitoring of the security situation in Nertiti.
- 2. Intensified UNAMID patrols in the IDP camps to be continued.
- 3. The Civil Affairs Section to monitor the mediation process between the security forces (GoS Military and Police) in Nertiti to determine areas of possible UNAMID intervention/support.
- 4. Sector leadership to meet with the Wali to commend his efforts, so far, in dealing with the situation and ascertain possible areas of UN/UNAMID intervention/assistance to avert further revenge from any of the two parties.
- 5. UNAMID Police to visit and assess the conditions of the injured victims at Nertiti Hospital.

We've done some thinking about what we're looking for, and see below a proposed structure. I hope this isn't too prescriptive and you can work with this? Don't feel obliged to stick with that exact structure/ ordering but this is an example of how we envision it. If you have any comments/ other suggestions then we're happy to consider them.

- 1. ANALYSIS: What are the main migration routes from and through Sudan? (show visually on a map). What are current trends? What are likely future scenarios? (eg economy, demographics, climatic patterns and potential effect on conflict and ultimately migration).
- 2. THE MIGRANT JOURNEY:
 - a. ERITREAN: Take the audience (with map) through the journey of an Eritrean migrant, from arriving in the East to departing from Libya, with possible events along the way eg, some register at the border, some don't; some go straight to Khartoum, some stay in the East; some will transit straight away northwards, some will stay to save money; some will transit to Europe via Libya, some via Darfur/ Chad; some may be trafficked/ kidnapped (so what happens?); some may be intercepted by the Sudanese in the north and returned. Etc etc
 - b. SUDANESE: Talk about some of the drivers for onward movement conflict, economic hardship, climate change giving examples where possible.
- 3. GOVERNMENT RESPONSE: What are government's migration priorities? How do they see issues of transit/ travel northwards? Where are they open to engagement, and what areas are more difficult?
- 4. INTERNATIONAL RESPONSE:
 - What has been achieved in Sudan? (reference UK projects eg IoM judiciary/research/DTM, UNHCR South Sudanese programme)
 - What could be achieved, if resources were significantly scaled up?
 - What are the main issues/ risks: eg, weak government/ NGO capacity, risks of dealing with state apparatus and how to mitigate them

Background: Sudan

1. [REDACT SECTION 27]

2. In January 2014, President Bashir launched a 'National Dialogue' that would be open to all political parties, civil society and rebel groups, which aimed to address the fundamental issues facing the country (conflict, poverty, political reform and national identity). It was launched in October 2015 and ended on 10 October 2016. The Government of Sudan published recommendations, and said that the process would remain open for members of the opposition to join.

Internal conflicts

- 3. Large parts of Sudan remain unstable. Temporary ceasefires in Darfur and the Two Areas of Blue Nile and South Kordofan were announced in September 2015 by both the Government of Sudan (GoS) and the opposition. However, fighting resumed in January 2016 when the GoS began a major bombing campaign in the Jebel Marra region of Darfur, which displaced 130,000 people from their homes. A cessation of hostilities (CoH) in the Two Areas was announced by the Government of Sudan on 17 June, and President Bashir then declared that this would be extended until the end of 2016. During his New Year's address, Bashir confirmed that the ceasefire would be extended again until the end of January 2017.
- 4. The African Union High-Level Implementation Panel (AUHIP), under former South African President Thabo Mbeki, has attempted to mediate the conflicts. Following pressure from the international community, including the UK, several key opposition groups signed the AUHIP's roadmap towards peace in early August, following on from the signature of the Government of Sudan in March. This represented the most significant breakthrough in Sudan's peace process for two years, although subsequent talks on agreeing a CoH and ensuring unfettered humanitarian access to the conflict areas disappointingly broke down the following week.
- 5. On 29 September Amnesty International released a report alleging the use of chemical weapons in Darfur. **[REDACT SECTION 27]** However, the allegations remain very difficult to substantiate/refute given access restrictions on the UN/AU Peacekeeping Mission (UNAMID) and others. Sudan is also a state party to the OPCW, so unless another state party presents additional evidence and presses for a challenge inspection the OPCW cannot investigate further. Furthermore, a high threshold of evidence is required to invoke a challenge inspection; as such it has never been used.
- 6. The UK leads on UNAMID at the UN Security Council, and the mandate was most recently renewed for 12 months in June. The mission continues to face access restrictions and bureaucratic impediments from all parties to the conflict, and the Government of Sudan are adamant that UNAMID is not needed and should be withdrawn. We continue to make clear that before any significant moves towards the mission's exit can be made, conditions on the ground must significantly improve.

7. UN Security Council Resolution 1593, adopted in March 2005, referred the situation in Darfur to the International Criminal Court (ICC) and required all states to cooperate fully with the investigation. President Bashir was subsequently charged by the ICC with genocide, war crimes and crimes against humanity in Darfur, and arrest warrants were issued for him in 2009 and 2010. Two other members of the Sudanese government were also indicted. The UK, in coordination with the EU, has a policy of avoiding all "non-essential contact" with ICC-indicted persons subject to an arrest warrant. Bashir has continued to travel and cross borders with impunity. Recently, a number of State parties to the ICC have failed to cooperate fully with the Court and arrest him; most notably South Africa in June 2015, following which the ICC will convene a hearing in April 2017 on the issue of non-compliance.

Development and humanitarian

- 8. Sudan is a fragile state in a fragile region. Over 50% of Sudanese suffer from chronic poverty, and nearly 6 million people are in need of humanitarian assistance, the majority of who have been displaced by protracted conflict. By 2020, DFID Sudan's vision is that Sudan's most vulnerable and excluded people are increasingly able to meet their basic needs, sustain their livelihoods, build their resilience to crises, and engage in laying the foundations for a more democratic, inclusive and peaceful future.
- 9. Progress remains challenging, with a difficult operating environment, government restrictions on movement and access, and capacity constraints amongst implementing partners. We are working with the international development community to shift focus to longer-term humanitarian approaches, then into early recovery, resilience, and development. This is in keeping with our commitments from the World Humanitarian Summit, and our own efforts to better engage in Sudan's protracted crisis. In Darfur, we are developing a portfolio approach that will look to manage our entire engagement in Darfur as a whole, with the ability to move resources from humanitarian to early recovery and development as the local context changes.
- 10. DFID plans to invest at least £50m per year in Sudan over the next four years. The majority of our programming is humanitarian and resilience-focused, alongside development programmes including water, governance, and countering climate change and female genital cutting. Our innovative Adapt! programme will influence the government and the international community to put climate change adaptation at the centre of our work. We are strengthening our relationship with the Ministry of Finance in an effort to support better macro-economic management through a World Bank managed Trust Fund; and working with local communities and youth groups to strengthen citizen voice and engagement.

Human rights

11. Sudan remains an FCO Human Rights Priority Country. Our human rights priorities in Sudan are conflict resolution and humanitarian access, pressing for greater civil and political freedoms, and tackling sexual and gender-based

violence. We successfully lobbied for the mandate of the Independent Expert on the human rights situation in Sudan to be renewed in September.

- 12. Recently, 76 opposition figures, including many senior party members (the majority from the Sudanese Congress Party) have been arrested following protests against the government's recent economic reforms. HMA Khartoum raised the issue with the Director of the European Division of the Sudanese Ministry of Foreign Affairs on 20 November, and the UK Special Representative for Sudan and South Sudan did likewise with the Sudanese Ambassador to London on 30 November. The Troika, EU and Canada released a joint statement on 7 December condemning the continued detentions.
- 13. Sudan ranks 174th out of 180 on the Reporters Without Borders World Press Freedom Index and newspapers are frequently confiscated. We have seen restrictions placed on civil society, including the prevention of human rights defenders travelling to Geneva during Sudan's Universal Periodic Review. We continue to follow the trial of employees of TRACKs, a local NGO carrying out human rights training. The individuals have been accused of a number of crimes, including waging war against the state, which carries the death penalty.
- 14. Freedom of religion or belief continues to be a matter of concern, with apostasy still considered a crime in Sudan. FGM is also a major issue in Sudan, with 87% of women aged 15-49 reporting having undergone some form of FGM. The national strategy to abandon FGM in a generation is a positive step.

Migration and Sudan's regional role

- 15. Sudan is a major source, transit, and host country for migration. It is consistently amongst the top five sources of asylum claims to the UK, hosts 360,000 refugees and is an established trafficking and people smuggling route. A range of interventions across HMG are being taken to tackle migration in and from Sudan. The Khartoum Process, which the UK currently chairs, is a regional mechanism for European and Horn of Africa countries to tackle trafficking and smuggling in partnership. The Khartoum Process aims to coordinate joint efforts between countries to better manage migratory flows and act against the criminal networks of people smugglers and traffickers. It will also monitor the implementation of the Valletta Action Plan and feed into EU Trust Fund discussions.
- 16. A €1.8 billion EU Emergency Trust Fund for Africa was announced at the Valletta Summit on Migration in November 2015 to help support a comprehensive solution to irregular migration, including addressing its root causes. The Trust Fund includes a €100 million Special Measure for Sudan. The 'Better Migration Management' (BMM) is regional project in the Horn of Africa, worth EUR 40 million, financed under the EU Trust Fund and designed to improve migration management in the Horn. No projects have started yet the first two are likely to be on migration legislation and on protection.
- 17. In the immediate aftermath of the fighting in South Sudan in July 2016, Riek Machar was in a poor state of health and went to Khartoum on purely medical grounds. We made clear to the Government of Sudan that they should not allow

any actions (including statements) that are aimed at destabilising South Sudan, and they outlined to us that Machar would not be allowed to make any public statements whilst receiving treatment in Khartoum. We welcomed calls from the region for Machar to leave the country, and he did so on 11 October; heading for South Africa.



In the longer-term, we aim to influence a lasting peace process that results in a more inclusive, representative and legitimate government. We want to help Sudan to use its resources to meet the basic needs of all its people. We will facilitate increased prosperity and opportunities for employment to enable Sudanese people as well as regional migrants to establish more productive lives.

DFID plans to invest at least £50m per year in Sudan over the next four years, across 11 programmes. The majority of our programming is humanitarian and resilience-focused, alongside development programmes including water, governance, and countering climate change and female genital cutting. The difficulties of working in Sudan should not be underestimated: government controls impact on partner access and activities, and financial sanctions further impact on our partners' ability to deliver. No financial aid is provided directly through the government of Sudan.

2016/17 Bilateral programme by sector



OFFICIAL SUDAN: ECONOMY: REFORMS FUEL RESENTMENT [DIPTEL 1605235]

07/11/2016

Summary

The Government of Sudan (GoS) announces major economic reform package to cut the budget deficit and generate foreign exchange. Similar move in 2013 led to widespread unrest and numerous deaths of protestors. Security services on high alert. Opposition leaders arrested and newspapers seized. Potential for public demonstrations and strikes. We should urge the GoS to exercise restraint. Implications for Travel Advice and the African Union Peace Process.

DETAIL

- 1. On 2 November, the Central Bank of Sudan announced the introduction of an 'incentive' exchange rate to allow commercial banks to trade in dollars at \$1=SDG 15.85 (the black market rate is over \$1=SDG16 compared to the official rate of \$1=SDG 6.88) designed to slow the decline in Sudan's rapidly diminishing foreign exchange reserves. The next day the Minister of Finance announced a major economic reform package including the removal of subsidies on fuel (leading to a 50% increase in the price of petrol), an increase in electricity prices (also a 50% increase), a ban on the import of certain items (meat, fish and livestock), increased 'Zakat' (Zakat in Sudan is a poorly targeted social security mechanism (DFID have begun work with the World Bank to improve this), but may offer an element of assistance for those worst affected) and a 20% increase in Government salaries. These measures are certain to fuel inflation.
- In a speech to the ruling National Congress Party (leaked on social media), President Bashir warned of hard days ahead, as well as the potential for unrest. He claimed that the measures would not affect the poorest people: the first 400KW of electricity usage will be exempted from the increased rate and the increase in Zakat and Government salaries will compensate for the price increases.
- 3. The backdrop is a deteriorating economy suffering from currency depreciation, rising food prices and a chronic shortage of foreign exchange. The IMF had proposed the flotation of the exchange rate and the removal of subsidies as part

of their Staff Monitored Programme in 2014 (which the Sudanese rejected at the time). The introduction of the 'incentive rate' falls short of flotation (and has led to considerable confusion about how it will work). Removing subsidies completely without adequate preparation or effective social protection is likely to adversely affect the poor **[REDACT SECTION 27]** says.

- 4. The GoS are nervous about the public reaction. All police units have been put on full alert. The security services have also begun rounding up a number of high profile political figures who have publicly criticised the new policies, as well as those calling for demonstrations and protests. Several have been in detention since the weekend. Three newspapers have also been confiscated by the GoS following critical coverage. Opposition parties, along with some inside the Government coalition, have been highly critical of the new policies, calling for their suspension. They cite a lack of transparency and no corresponding reduction in Government expenditure on the security forces.
- 5. In September 2013, following a similar removal of fuel subsidies, widespread protests were seen in a number of cities across Sudan. The protests were met with a fierce reaction from the security services, including the use of live ammunition which led to between 80 (GoS figure) and 200 (NGO figure) civilian deaths. As a result, people are reticent to take to the streets to vent their anger. There is talk of strikes as an alternative. Much will depend on the level to which opposition parties look to capitalise on the opportunity and encourage people to demonstrate. Some have already done so. The opposition parties overplay their ability to bring large numbers of people to the street, but there remains a real possibility of protests once the measures really start to bite.

Summary

Tantalising opportunity for Sudan to follow Cuba and Iran in shedding sanctions before the end of the Obama term. US roadmap specifies four main conditions, including ending conflict in Darfur and the Two Areas. Visit by [REDACT SECTION 40] reveals deep mistrust of American promises but also desire for UK help.

US-Sudan relations

- 1. In June, the US and Sudan agreed on a roadmap detailing reforms in four main policy areas: deliver these, the Sudanese were told, and President Obama will suspend economic sanctions before he leaves office. The four conditions chime with our interests: cease internal conflict, allow full humanitarian access across Sudan, cooperate for peace in South Sudan [REDACT SECTION 24]
- 2. Despite the huge incentive (sanctions are crippling economic activity), the Government of Sudan (GoS) are stalling in two of the four areas. They have blocked African Union-led efforts for a cessation of hostilities in the Two Areas (South Kordofan and Blue Nile). The SPLM-N rebels insist on a small portion of aid being allowed to come over the border from Ethiopia, which GoS view as a smokescreen for importing weapons. In fact, the rebel demand is merely a face-saver and the Ethiopians have agreed that Sudanese customs may verify the packages inside Ethiopia before delivery. Yet despite heavy international pressure, including from the UK, GoS have not budged.
- 3. GoS have also **[REDACT SECTION 27]** by sheltering the South Sudanese opposition leader Riek Machar, **[REDACT SECTION 27]** on medical grounds. But he continues political activities and on 25 September issued a belligerent statement from Khartoum. In addition, in early August, Sudanese security locked up 15 activists in Darfur who'd had the temerity to speak to the US Special Envoy.

4. But there's plenty of life in the roadmap: last week the State Department publicly welcomed Sudanese CT cooperation and hosted a sanctions briefing for domestic and foreign banks to avoid over-compliance. The US Special Envoy met the key Sudanese players in the margins of UNGA for a fourth monthly stock-take.

UK phased engagement

- 5. Ministers agreed to enhance UK-Sudan relations through a 'phased engagement' policy earlier this year as the most effective way of persuading the Sudanese regime to shun pariahdom. That requires presenting the UK as an active, nimble player whose policies are calibrated to recognise changes in GoS behaviour.
- 6. Phased engagement <u>is</u> making early progress: on migration, GoS is cooperating with post and the **[REDACT Section 23]** on tackling people-smuggling; on conflict, GoS has openly started acknowledging the UK as a helpful player in the peace process after we coordinated substantial international pressure on the rebel groups to sign the AU Roadmap for Peace; and on development, GoS views positively DFID's efforts to channel donor opinion towards doing more early recovery and development. Visas and permits that used to take months are being processed almost instantly.
- 7. In his first visit to Khartoum on 19-21 September, the new [REDACT SECTION 40] urged the Government to demonstrate flexibility and strategic vision to achieve a cessation of hostilities, essential for the US deal. [REDACT SECTION 40] reminded them the American roadmap was a rare, time-limited offer: it would not be available under a new US administration for many years, if at all.
- [REDACT SECTION 27] As a Troika ally (along with Norway), [REDACT SECTION 27] MFA State Minister Ismail and Presidential Advisor Al Mahdi both told [REDACT SECTION 40] the UK must lean on the US to lift sanctions, something I hear frequently from Sudanese across the board. [REDACT SECTION 27]
- 9. Equally, **[REDACT SECTION 27]**. Our phased engagement with Sudan is broader and covers conflict, human rights, illegal migration, extremism, development and regional issues, particularly South Sudan.
