Within 8 weeks of the start date [by 19 December 2017]

Everyone who has made an objection or representation or any other written representation must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send full copies to the Authority. Copies (excluding copies of any supporting documents - these will be available to view at the Authority's offices) will also be sent to the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Order.

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, Secretary of State will send a full copy to the Authority. Copies will also be sent to everyone who has made an objection or representation and any other person who has written to us in respect of the Order (excluding copies of any supporting documents - these will be available to view at the Authority's offices).

Within 14 weeks of the start date [by 30 January 2018]

Everyone who has made an objection or representation, the Authority, the applicant (if applicable) and anyone who has written to us in respect of the Order must ensure that their comments on any or every other statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of these comments to everyone else.

Any other person wishing to make representations in writing to the Secretary of State in respect of the above Order must do so in line with the timetable set out above.

In fairness to the other parties <u>everyone should keep to the timetable</u> to ensure that statements of case and comments are received on time. Late documents will be returned.

THE NOTTINGHAMSHIRE COUNTY COUNCIL (EAST MARKHAM BYWAY NOS. 27, 28, 29, 30, 31 & 32) MODIFICATION ORDER 2005

This Order is made by the Nottinghamshire County Council under Section 53(2)(b) of the Wildlife & Countryside Act 1981 ("the Act") because it appears to that Authority that the Nottinghamshire (Area 6)Definitive Map and Statement require modification in consequence of the occurrence of events specified in Section 53(3)(c)(i) of the Act, namely the discovery of evidence that rights of way subsist or are reasonably alleged to subsist over land situated at East Markham, and in Section 53(3)(c)(ii) of the Act, namely the discovery of evidence that parts of the highways shown as bridleways over land situated at East Markham ought to be shown as Byways.

The Authority have consulted with every Local Authority whose area includes the land to which the Order relates.

The Nottinghamshire County Council hereby order that:

- For the purposes of this Order the relevant date is 1st July 2005.
- 2. The Nottinghamshire (Area 6) Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the Map attached to this Order.
