The effect of the Order, if confirmed without modifications, will be to modify the definitive map and statement for the area by adding a Byway Open to All Traffic commencing in the parish of Grindale on Boynton Lane to the north of Fox Covert Plantation at Grid Reference TA 1305 7052 and leading west-north-westerly along Fox Covert Lane for some 705 metres to the end of the lane at Grid Reference TA 1235 7063 then west-south-westerly through Fox Covert Plantation for some 105 metres to Grid Reference TA 1226 7057 then south-westerly on the south side of the field boundary for some 985 metres to join the eastern end of High Caythorpe Lane at High Caythorpe Farm at Grid Reference TA 1151 6994.

### Within 2 weeks of the start date [by 04 July 2017]

As soon as possible after the deadline, the Secretary of State will send a copy (excluding copies of any supporting documents - these will be available to view at the Authority's offices) to everyone who has made an objection or representation, the applicant and any other person who has written to us in respect of the Order.

### Within 8 weeks of the start date [by 15 August 2017]

Everyone who has made an objection or representation or any other written representation must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send full copies to the Authority. Copies (excluding copies of any supporting documents - these will be available to view at the Authority's offices) will also be sent to the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Order.

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, Secretary of State will send a full copy to the Authority. Copies will also be sent to everyone who has made an objection or representation and any other person who has written to us in respect of the Order (excluding copies of any supporting documents - these will be available to view at the Authority's offices).

### Within 14 weeks of the start date [by 26 September 2017]

Everyone who has made an objection or representation, the Authority, the applicant (if applicable) and anyone who has written to us in respect of the Order must ensure that their comments on any or every other statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of these comments to everyone else.

Any other person wishing to make representations in writing to the Secretary of State in respect of the above Order(s) must do so in line with the timetable set out above.

In fairness to the other parties <u>everyone should keep to the timetable</u> to ensure that statements of case and comments are received on time. Late documents will be returned.

This Order is made by The East Riding of Yorkshire Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ('the Act') because it appears to that authority that the Humberside County Council Borough of East Yorkshire Definitive Map and Statement of Public Rights of Way require modification in consequence of the occurrence of an event specified in section 53(3)(c)(i) of the Act, namely the discovery by the authority of evidence which (when considered with all other evidence available to them) shows that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a byway open to all traffic.

The authority has consulted with every local authority whose area includes the land to which the Order relates. The East Riding of Yorkshire Council hereby orders that:

- 1. For the purposes of this Order the relevant date is 1 July 2016.
- 2. The Humberside County Council Borough of East Yorkshire Definitive Map and Statement of Public Rights of Way shall be modified as described in Part I and II of the Schedule and shown on the map attached to the Order.
- 3. This Order shall take effect on the date it is confirmed and may be cited as The East Riding of Yorkshire Council (Rudston No. 10, Boynton No. 5 and Grindale No. 1). Definitive Map and Statement Modification Order 2016.


