I would be grateful if you could send me details of all visits made by Cabinet-level ministers to the USA during period of the Coalition government between 2010 and 2015. The details I'm interested in are:

Name of minister.

Date the visit began and ended.

If possible, within the time limit, I would also be interested to know:

Which members of the US government that the minister spoke to.

Whether there was any particular purpose for the visit other than talks with members of the US government.

I am writing to confirm that we have now completed the search for the information which you requested.

I can confirm that the Foreign and Commonwealth Office (FCO) does hold information relevant to your request. The information we hold is for the Secretary of State for Foreign and Commonwealth Affairs is in the table enclosed.

Once an FOI request is answered, it is considered to be in the public domain.
