Thank you for your email of 19 September 2017 in which you requested the following information:

'Thank you for the response, I have requested my fathers records and have received them back. This was completed last year. On his records it states that he was at Naval Party 5555.

I already have clarification of his participation in Naval Party 5555, what I am looking for is clarification that Naval Party 5555 as a unit was on Christmas Island, participating in Operation Dominic. Not specifically his participation.'

Your enquiry is being treated as a request for information under the Freedom of Information Act 2000.

A search has now been completed within the Ministry of Defence (MOD) and I can confirm that some information in scope of your request is held.

The Department can confirm that Naval Party 5555 was the Naval Party at Christmas Island. Under section 16 (Advice and Assistance) of the FOI Act, I can advise that all records have been transferred to The National Archives and are held under Operation Brigadoon (also DOMINIC) reference DEFE 7:

Alternatively, you may consider employing a researcher to carry out the work for you. If you do decide to do this, then the National Archives will supply you with a list of independent researchers who will make a charge for their time. The National Archives do not carry out research on individual members of the public's behalf.
