Thank you for your email of 17 October 2017 requesting the following information:

- "- How many Service Families Accommodation(SFA) houses there are at BRNC Dartmouth by grade and entitlement, together with confirmation as to how many are presently occupied by personnel serving at BRNC?
- The number of people currently waiting for SFA at BRNC Dartmouth by:
- -- grade of SFA they are waiting for? -- whether they are serving at BRNC?, and
- -- how long they have been waiting?
- How many BRNC SFA have been used for Single Living Accommodation (SLA) by grade and dates over the last 10 years (including those currently occupied as SLA)?
- How many BRNC staff are currently accommodated in Substitute Service Families Accommodation (SSFA), together with the current monthly cost of this?"

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence (MOD) and I can confirm that all the information in scope of your request is held. The information you have requested can be found enclosed, below:

1) How many Service Families Accommodation(SFA) houses there are at BRNC Dartmouth by grade and entitlement, together with confirmation as to how many are presently occupied by personnel serving at BRNC?

The number and type of Service Family Accommodation properties at BRNC Dartmouth are shown in the table below:

Out of a total of 36 occupied properties, 17 are occupied by personnel serving at BRNC.

- 2) The number of people currently waiting for SFA at BRNC Dartmouth by:
 - -- grade of SFA they are waiting for?
 - -- whether they are serving at BRNC?, and
 - -- how long they have been waiting?

There is currently one application for a surplus property awaiting allocation from a single service personnel. This was submitted in May 2017. The application has not been progressed as CarillionAmey are still awaiting a response from the applicant indicating an address preference.

3) How many BRNC SFA have been used for Single Living Accommodation (SLA) by grade and dates over the last 10 years (including those currently occupied as SLA)?

Only 1 SFA (Type 5S) has been used for Single Living Accommodation in the last 10 years since 01 May 2013.

4) How many BRNC staff are currently accommodated in Substitute Service Families Accommodation (SSFA), together with the current monthly cost of this?"

There is one BRNC staff in Substitute Service Families Accommodation. The rental amount for this property paid by MOD is £1521.85 per month.
