### Information request

 Benefit Type: Data represent the number of children dependent on a parent or guardian who is claiming one or a combination of the following out-of-work benefits: Income Support (IS), Jobseeker's Allowance (JSA), Employment and Support Allowance (ESA), Incapacity Benefit (IB) and Severe Disablement Allowance (SDA), and Pension Credit (PC).

There is a considerable overlap in the breakdown by benefit type, as for example, a claimant of Income Support may also be claiming Incapacity Benefit alongside. The **All Out of work Benefits** column captures children once, irrespective of the combination of benefits being claimed by parents or guardians.
