Thank you for your email of 4 March in which you requested the following information:

"Thank you for your response. As per the letter you sent, please could you provide the information for the last two years, which I take to mean 2015 and 2016 as calendar years."

This was a follow-on to an earlier request in which you had asked for the following information:

"I would like to request the financial income generated by Joint Helicopter Command (JHC) in relation to aircraft attending public events, such as airshows, photography events, village fairs, and the like, based on the fees levied for by JHC for helicopter participation at said events.

I would like to request this information in a breakdown per year and per event - if available - since JHC's inception in October 1999."

I am treating your correspondence as a request for information under the Freedom of Information Act 2000.

A search for the information has now been completed within the Ministry of Defence, and I can confirm that information in scope of your request is held and is attached

If you are not satisfied with this response or you wish to complain about any aspect of the handling of your request, then you should contact me in the first instance. If informal resolution is not possible and you are still dissatisfied then you may apply for an independent internal review by contacting the Information Rights Compliance team, Ground Floor, MOD Main Building, Whitehall, SW1A 2HB (e-mail CIO-FOI-IR@mod.uk). Please note that any request for an internal review must be made within 40 working days of the date on which the attempt to reach informal resolution has come to an end.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not investigate your
