Thank you for your email of 31 July 2017 requesting the following information:

Since the initiation of the SFA compensation scheme on 1 Apr 2017, as detailed in the SFA compensation scheme fact sheet (link here), how many claims for missed appointments have been received by the DIO; of that amount, how many missed appointments claims have been approved. In addition, of the approved claims how many claimants have received the vouchers that were offered under the compensation scheme.

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence (MOD) and I can confirm that all the information in scope of your request is held. The information you have requested can be found below.

How many claims for missed appointments have been received by the DIO? From 1 April 2017 to 8 August 2017, 725 claims have been received by DIO for missed appointments.

Of that amount, how many missed appointments claims have been approved? 439 have been approved for payment.

Of the approved claims how many claimants have received the vouchers that were offered under the compensation scheme?

No claimant has received voucher payment.

Under Section 16 of the Act (Advice and Assistance) you may find it helpful to note that although the scheme commenced on 1 April 2017, the imposed tight timescale for its introduction meant that not all of the required processes were established at that time, including one to deliver voucher payment. However, the system for issuing vouchers is now in place and we will begin issuing vouchers from Monday 4 September. As I am sure you will understand, there is a backlog which may take up to a month to work through but all successful applicants have been kept informed about the delay in introducing the voucher payment system.
