- 2. Working age benefits are classified as the following; Bereavement Benefit (BB), Carer's Allowance (CA), Disability Living Allowance (DLA), Employment and Support Allowance (ESA), Incapacity Benefit (IB) / Severe Disablement Allowance (SDA), Income Support (IS), Pension Credit (PC) and Widow's Benefit (WB).
- 3. Age group is calculated at the reference date. It is derived from the reference date and the client's date of birth.

- 5. May 2012 is the latest date for which information is available for JSA sanctions data by Parliamentary Constituency.
- 6. ESA replaced IB and IS paid on the grounds of incapacity for new claims from 27th October 2008.
- 7. From 6 April 2001, no new claims to SDA were accepted. In addition from 27 October 2008, no new claims to IB were also accepted.
- Pension Credit was introduced on 6 October 2003 and replaced Minimum Income Guarantee (Income Support for people aged 60 or over). The vast majority of people who were previously in receipt of the Minimum Income Guarantee transferred to Pension Credit in October 2003.
- 9. The age at which women reach State Pension age is gradually increasing from 60 to 65 between April 2010 and April 2016 to November 2018. Under current legislation, State Pension age for men and women is planned to increase to: 66 between November 2018 and October 2020; 67 between 2034 and 2036; 68 between 2044 and 2046. This will introduce a small increase to the number of working age benefit recipients and a small reduction to the number of pension age recipients. Figures from May 2010 onwards reflect this change. - 2. **Sanctions applied:** The number of sanctions applied is the number of Varied⁶, Fixed Length⁷ and Entitlement Decision⁸ referrals where the decision was found against the claimant.
- 3. **Month of decision:** The month in which the decision to apply a sanction was made. May 2012 is the latest date for which information is available for JSA sanctions data by Parliamentary Constituency.
- 4. Age group of the claimant is calculated at the date the referral for a decision was made.

- 6. Varied Length sanctions: A sanction of between 1 week and 26 weeks is imposed for leaving employment voluntarily without just cause, refusing employment without good cause, or losing employment through misconduct. The actual period in each case is at the discretion of the Adjudication Officer who makes the decision.
- 7. **Fixed Length sanctions:** A sanction of between 1 week and 26 weeks is imposed for refusal, without good cause, to attend an employment programme or carry out a Jobseeker's Direction. Payment of benefit continues in full pending the Adjudication Officer's decision on a sanction question.
- 8. **Entitlement Decisions:** These are questions on which entitlement to JSA depends. For example, if there is doubt around whether the Jobseeker's agreement (JSAg) is suitable, whether they are actively looking for work or making themselves available for work. In most cases payment of JSA will be suspended by benefit processing until the doubt is resolved.

I can confirm that the Department does hold some information on the number of people in receipt of Crisis Loans in Tonbridge and Malling parliamentary constituency broken down by age group. However, we estimate that the cost of fully complying with your request would exceed the appropriate limit of £600. The data referenced above is the closest information available within this limit.

The appropriate limit has been specified in regulations and for central Government it is set at £600. This represents the estimated cost of one

person spending 3½ working days in determining whether the Department holds the information, and locating, retrieving and extracting the information. Under section 12 of the Freedom of Information Act the Department is not obliged to comply with your request and we will not be processing your request further.
