Dear XXXXXXXXX

Thank you for your email of 15 November in which you requested the following information:

*How many soldiers who enlisted in the army aged a) under 18 and b) 18 years and above dropped out before completing Phase Two training in each of the last five financial years and how many were a) voluntarily discharged b) medically discharged, c) administratively discharged and d) made redundant?*

A search for the information has now been completed within the Ministry of Defence, and I can confirm that information in scope of your request is held. For the purposes of this FOI, 'dropped out' has been interpreted as all outflows from the Army. The table below shows the number of untrained Regular soldiers who outflowed from the Army by age group on enlistment and exit category.

Notes:

- The figures are for Regular Army Personnel only and therefore exclude Gurkhas, Full Time Reserve Service and Mobilised Reserves.
- Untrained outflow refers to personnel who left Regular Army before completing their Phase 2 training.
- The figures are for outflow of untrained Regular soldiers broken down by financial year of outflow regardless of when they inflowed.

- Age on enlistment is calculated using date of birth and entry date. JPA is supposed to reflect 'current entry date' but if personnel have transferred to the Army from another Service, served under an alternative assignment type (e.g. reserve forces), are re-entrants or have transferred from Other Ranks to Officers, their entry date may correspond to any of these events.
- Exit Category is as recorded in the Joint Personnel Administrative System. There are known data quality issues with these data, with many records having missing or incorrect exit categories. These are recorded as unknown in the tables above.
- Redundancy is not applicable to untrained Regular Army Personnel.
- Medical outflow statistics in the table above (which may include deaths) should be considered a single Service estimate and may differ from other official statistics due to different source data.
- The age shown above is the age on enlistment as opposed to the age upon exit.
- For presentational purpose, figures have been rounded to 10; numbers ending in "5" have been rounded to the nearest multiple of 20 to prevent systematic bias. Totals and sub-totals have been rounded separately and so may not appear to be the sum of their parts.
