6	Assessment Inspection and Audit	This chapter was Chapter 8 in previous edition of JSP 498. Para 2 updated to show audit programme will be issued on annual basis and show the next 2 years intentions. Periodicity of assessments may be reduced from 5 years to 3 years due to concerns around continuity of establishment staff where there are significant numbers of staff on short term deployments or a high proportion of establishment staff are replaced on mass. Assessment visit and exercise inspection processes would be aligned so they will be completed in one visit. Current MACR programme has been issued on this basis – dated April 2013 Para 12.5 MACR certificates will now start their 5 year life from the date of the assessment (rather than the date any action plan is completed). The previous system could allow in excess of 7 years between assessments which is not in line with Seveso III requirements. Para 14 introduces a new requirement for the MACR CASG to undertake an additional site visit 6 months after issuing an Improvement Notice. This is a requirement under Seveso III. MACR CA may wave this requirement if there is evidence that a further visit will not assist in resolving any non conformity. Para 15 reinforces rationale of start date for 5 year certificate period. Para 19 updated to reflect formation of DSEA and the role the Director DSEA would play in the dispute / appeal system. Para 22 improved explanation that removal of MACR certification (due to concerns over standard of compliance with JSP 498) will trigger a full reassessment within a 6 month period.

Chapte r 7	Environmental Risk Assessment	Chapter 7 is a new chapter which shows the requirements for Environmental Risk Assessments to meet MACR requirements. The chapter is based on the previous editions chapter 3 ERA elements and annexes 3H, 3J and 3K. The intention is to concentrate on the JSP 498 requirements. Further guidance is then signposted to the DSEA/DOSR web pages on MODWEB. On MODWEB we will be hosting a copy of the Environmental Science Groups MACR ERA Method Guidance Notes and a number of examples of completed ERA's which have meet the standard and are considered as exemplars. Para 10 reinforces that Environmental Impact Assessments required by JSP 418 will not meet the requirements of MACR although they can be used as a filtering methodology to focus in on which Environmental Aspects at an establishment could produce a MACR scenario.
