On 5/6-11-2013 at 11-30 at night a group of allied forces "British" in a very shocking and unexpected manner broke into my property, breaking the outside and inside door. One of the soldiers shot Muhammed who is my relative as well as my brother in-law whom was a guest in our house at the time. He was wounded and taken to the hospital, please record the information I gave. Also, for your information, the British forces inspected my house found nothing illegal then apologised to me and told me that the raid was through false allegations. I want to make a complaint and also a claim for compensation.

#### Witnessed as follows:

On 5/6-11-2003 at 11-30 at night I was at home with my wife and our guest Muhammed Abdul-ritha Salim. Suddenly, my house was raided by a massive group of British forces, they broke into my property breaking the outside and the inside door entering in a very bad and unexpected manner. One of the soldiers opened fire and shot Muhammed Abdul-ritha Salim in his belly injuring him, the whole house was inspected and turned upside down, messed up everything, damaged my furniture, broke one of the bedroom door upstairs, found nothing illegal, after that, they conveyed the injured to Al-Jubaila Military hospital. Then they apologised to me saying that it was a mistake and that the raid was based on false allegations. On 7-11-2003 Muhammed Abdul-ritha Salim died of his injuries, I want to make a complaint against the person who gave wrong information to the British forces and also against the group of soldiers who raided my house. I also want to make a claim for compensation as the deceased was married with three children, and was a teacher in Basra educational directorate.

My house is opposite to Mahmud Zabun's house, on 5/6-11-2003 at about 11-30 at night a group of British forces raided Mahmud Zabun's house, we heard a sound of a bullet fired then afterwards realised that one of the soldiers had shot Muhammed Abdul-ritha Salim who is Mahmud Zabun's brother in-law, then he was taken to the Al-Jubaila Military hospital, I knew then that the British forces had apologised saying that the raid was by mistake and that it was based on false allegations. I witnessed the group of soldiers who raided the house, and heard the sound of the bullet and saw when the injured was conveyed to the hospital. Then I knew that he died from his injuries after two days in the hospital.

On 5/6-11-2003 I was in my relatives house Mahmud Zabun as a guest, we were sitting down having our dinner when at about 11-30 a sudden raid without any prior notice or knock on the door by the British forces happened to the house. One of the soldiers opened fire randomly inside the house injuring Muhammed Abdul-ritha Salim. After that, we were told that the raid was by mistake and that it is not the house they intended to raid and that they had false allegations. Then the injured was conveyed to the AlJubaila Military hospital. After two days Muhammed died of his injuries at the hospital.

On 5-11-2003 at about 11-30 at night I was a guest at the house of the Lawyer Mahmud Zabun when we were shocked to see a group of British soldiers broke into the property breaking the outside and the inside door raiding the house. One of the soldiers opened fire randomly inside the house injuring Muhammed Abdul-ritha Salim with a bullet to his belly then he was taken to the hospital and died afterwards from his injuries. At the entrance of the British forces we were sitting normally having our dinner. Then they told us that the raid was by mistake and that it wasn't the house they intended. Then they conveyed the injured to Al-jubaila hospital where he died after two days from his injuries.



# To the main head quarter of the British forces in Basra Subject/ killing incident

On 5-6-11-2003 at 11-30 at night, Mahmud Zabun Dahash's house which is located in area exposed to a raid by the British forces where one of the soldiers opened fire on a victim Muhammed Abdul-ritha Salim, in which it lead to his death. A statement by the above mentioned name shows that the raid was based on false allegations, we have been asked by the judge to get into contact with you in-order to get the name of the person who gave you the wrong information.
