I am  WO2 Philip David Neville, RMP (SIB) and I am currently serving with 61 Sect SIB RMP at Waterloo Lines, Basrah Air Station, BFPO 641.

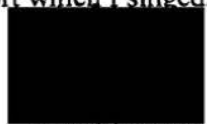
I am a qualified Scene of Crime Operator having passed an 8 week course of instruction at the RMPTS, Chichester, W Sussex between Jan – Mar 96.

Between 1430 hrs and 1700 hrs on Mon 27 Oct 04, at Basrah Air Station, I examined two MOD vehicles on charge to 40 Cdo RM. The vehicles were a Pinz Gauer, VRN: 79 KL 72 and a Land Rover Wolf, VRN: PE 20 AA. I examined the vehicles for any sign of damage consistent with being struck by any missile, shot or projectile.

Neither vehicle showed any signs of damage consistent with such a strike. I then photographed both vehicles using a Nikon F90X 35mm camera, loaded with 100ASA film. I retained the exposed film in my possession and then forwarded it to the Central Processing Cell, HQ SIB (UK) RMP, Bulford, via the registered mail system, for development.

I maintained a record of my examination on a RMP SOCO Report which I signed, dated and marked as exhibit PDN/1.
