## FOI 760, 331 REQUEST FOR '...Highways England's exposure to Carillion and its subsidiaries...'

I am writing regarding your request for information received on the04/03/2018. In that request, you asked us '...What was Highways England's exposure to Carillion and its subsidiaries? What has been done to address this? In terms of contract value, what monies have Highways England paid for works not undertaken by Carillion and its subsidiaries and what monies are owed by Carillion and its subsidiaries.'

Highways England had a limited number of live contracts with Carillion companies. Carillion was in joint ventures on 6 live construction contracts, namely -

• A14 Cambridge to Huntingdon Package 3 in joint venture with Balfour Beatty, a call off from the Collaborative Delivery Framework lot 3B for construction

• M20 J3 – 5 in joint venture with Kier Infrastructure & Overseas Ltd, a call off from the Collaborative Delivery Framework lot 3B for construction

• M20 J8 – 10 in joint venture with Kier Infrastructure & Overseas Ltd, a call off from the Collaborative Delivery Framework lot 3B for construction

• M6 J16 – 19 in joint venture with Kier Infrastructure & Overseas Ltd, a call off from the Collaborative Delivery Framework lot 3B for construction

• M6 J13 – 15 in joint venture with Kier Infrastructure & Overseas Ltd, a call off from the Collaborative Delivery Framework lot 3B for construction

• A1(M) Dishforth to Barton in in joint venture with Morgan Sindall, a standalone contract.

Where Carillion was in joint venture, the other joint venture party remain responsible and continues to deliver these contracts.

The form of contract used for these contracts was the NEC3 ECC Option C. Payment to the contractor under this contract form is total Defined Cost. As such, costs are paid in arrears and Highways England does not make payment for works not undertaken.

If you are unhappy with the way we have handled your request you may ask for an internal review within 2 months of the date of this response for Freedom of Information requests and within 40 days for Environmental Information Regulations requests. Our internal review process is available at:
