

## **Permitting decisions**

## Standard rules permit

We have decided to grant the permit for Tyseley Hydrogen Refuelling Station operated by ITM Power (Trading) Limited.

The permit number is EPR/KP3035JZ.

We consider in reaching that decision we have taken into account all relevant considerations and legal requirements and that the permit will ensure that the appropriate level of environmental protection is provided.
