NOTICE OF ORDER WILDLIFE AND COUNTRYSIDE ACT 1981 SECTION 53

The Sheffield City Council (Definitive Map and Statement) Modification Order (No. 59) 2016

Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Order.

The **start date** for the above Order is **05 September 2017**.

Consideration of the Order will take the form of a public local inquiry.

The Inquiry will be held at The Limes (Community Centre), Lime Street, Beighton, Sheffield, S20 1BL on 30 May 2018 at 10.00am.

The effect of the Order, if confirmed without modifications, will be to modify the Definitive Map and Statement for the area by adding to them the footpath commencing at Rotherham Road, Beighton (the point marked A on the Order Map, OS grid reference 444677:383980) and proceeding in a south-easterly direction to its junction with Footpath number 37 Beighton (the point marked B on the Order Map, OS grid reference 444677:383622). The number of this footpath to be known as 95.

This Order is made by Sheffield City Council under Section 53(2)(a) and (b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the Definitive Map and Statement (Former Derbyshire County Council Area, Definitive Map for the Parish of Beighton, Sheffield) require modification in consequence of the occurrence of an event specified in Section 53 (3) (c) (i) of the Act, namely, the discovery by the authority of evidence which (when considered with all other relevant evidence available to it) shows that a right of way which is not shown in the Map and Statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way to which Part III of the Act applies.


The authority has consulted with every local authority whose area includes the land to which the Order relates.

The Sheffield City Council hereby orders that:

1. For the purposes of this Order the relevant date is the 26th July 2016.
2. The Definitive Map and Statement (Former Derbyshire County Council Area, Definitive Map for the Parish of Beighton, Sheffield) shall be modified as described in Part I and Part II of the Schedule and shown on the Maps attached to this Order.
3. This Order shall take effect on the date it is made and may be cited as The Sheffield City Council (Definitive Map and Statement) Modification Order (No. 59) 2016.

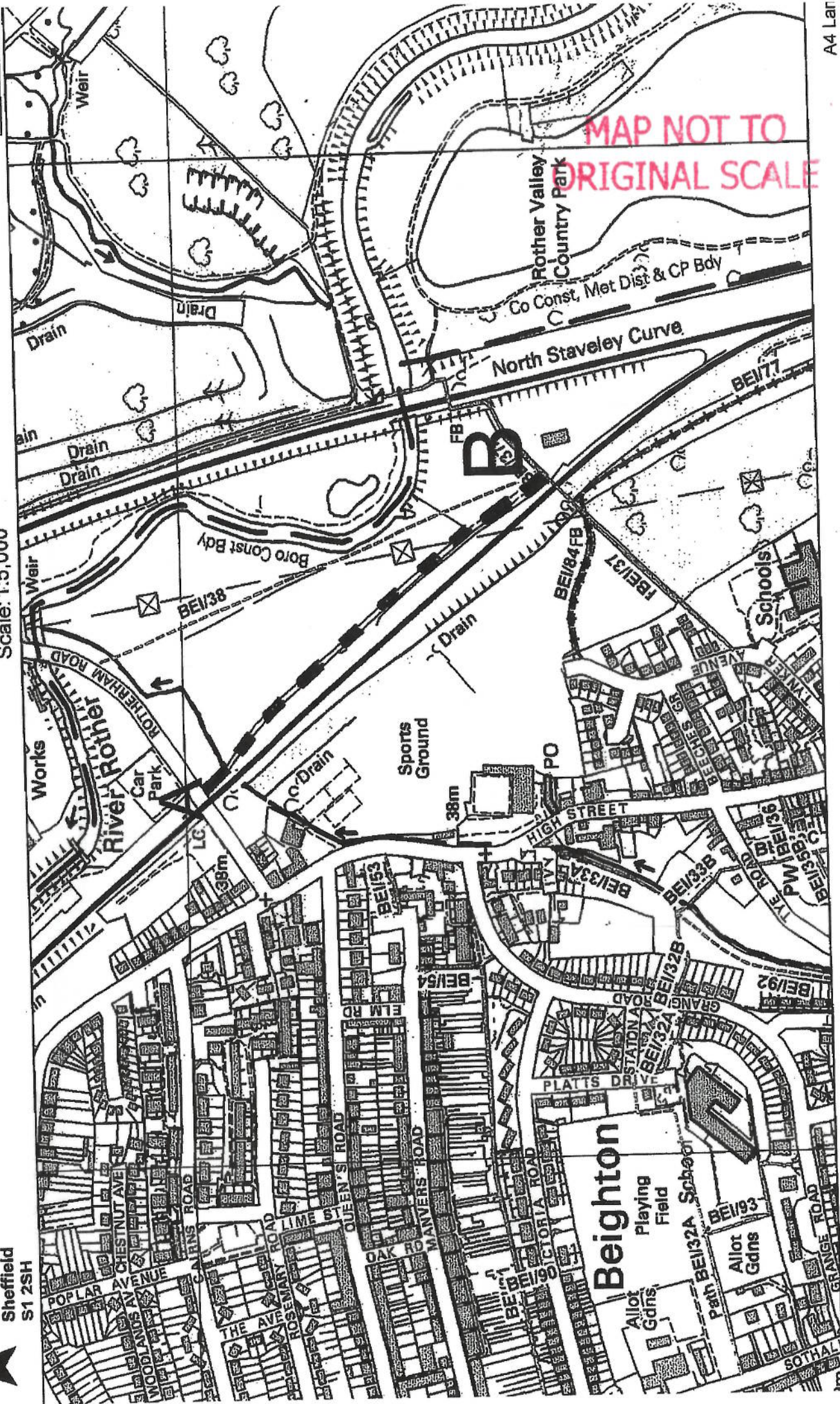
