The start date for the above Order is 06 March 2018.

Consideration of the Order will take the form of exchanges of statements of case and comments on statements of case.

The effect of the Order, if confirmed without modifications, will be to divert the public Bridleway running from SU 5158 4729 and proceeding north-westwards, along roughly metalled farm track to SU 5150 4743, to a line, 3 metres wide running from SU 5158 4729 proceeding generally north-westwards before curving north-eastwards via SU 5148 7472 to SU 5150 4743, as shown on the Order map. A total length of 213 metres.

As soon as possible after the deadline, the Secretary of State will send a copy (excluding copies of any supporting documents - these will be available to view at the Authority's offices) to everyone who has made an objection or representation, the applicant and any other person who has written to us in respect of the Order.

Within 8 weeks of the start date [by 01 May 2018]

Everyone who has made an objection or representation or any other written representation must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send full

copies to the Authority. Copies (excluding copies of any supporting documents - these will be available to view at the Authority's offices) will also be sent to the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Order.

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, Secretary of State will send a full copy to the Authority. Copies will also be sent to everyone who has made an objection or representation and any other person who has written to us in respect of the Order (excluding copies of any supporting documents - these will be available to view at the Authority's offices).

Within 14 weeks of the start date [by 12 June 2018]

Everyone who has made an objection or representation, the Authority, the applicant (if applicable) and anyone who has written to us in respect of the Order must ensure that their comments on any or every other statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of these comments to everyone else.

Any other person wishing to make representations in writing to the Secretary of State in respect of the above Order(s) must do so in line with the timetable set out above.

MODIFICATION ORDER 2017

This Order is made by Hampshire County Council ("the authority") under Section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the owner of the land crossed by the bridleway described in paragraph 1 of this order it is expedient that the line of the bridleway should be diverted.

This Order is also made under section 53A(2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the Hampshire Definitive Map and Statement of Public Rights of Way (dated 15th December 2007) require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) of the 1981 Act, namely, the diversion (as authorised by this order) of a highway shown or required to be shown in the map and statement.

The owners of the land crossed by the bridleway, have agreed to defray any compensation which becomes payable in consequence of the coming into force of this Order and any expenses which are incurred in bringing the new bridleway into a fit condition for use by the public.

Basingstoke and Deane Borough Council has been consulted as required by Section 120(2) of the 1980 Act.

BY THIS ORDER:

- 1. The public right of way over the land situated at Overton and shown by a bold continuous line on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up when Hampshire County Council has certified that the work necessary to bring the site of the new bridleway, specified in paragraph 3 below, into a fit condition for use by the public has been carried out, and thereupon the Hampshire Definitive Map of Public Rights of Way (dated 15th December 2007) shall be modified by deleting from it that public right of way.
- 2. Notwithstanding this Order all Statutory Undertakers shall have the same rights over the land referred to in paragraph 1 as they have hitherto enjoyed.

- 3. There shall be from the date of confirmation of this Order a public bridleway over the land situate at Overton described in Part 2 of the Schedule and shown by a bold broken line on the map contained in this Order, and thereupon the Hampshire Definitive Map of Public Rights of Way (dated 15th December 2007) shall be modified by adding that bridleway to it.
- 3A. The Hampshire Definitive Statement of Public Rights of Way (dated 15th December 2007) shall be modified as described in Part 4 of the Schedule to this Order.

PART 1

DESCRIPTION OF SITE OF EXISTING RIGHTS OF WAY

From SU 5158 4729 to SU 5150 4743

That part of Bridleway No.26 in the Parish of Overton, District of Basingstoke and Deane that commences at Point A on the map and proceeds northwestwards, along roughly metalled farm track to Point C.

A total length of 160 metres.

PART 2

<u>DESCRIPTION OF SITE OF NEW RIGHT OF WAY</u>

From SU 5158 4729 to SU 5150 4743 via SU 5148 4742

A Bridleway, 3 metres wide, in the Parish of Overton, District of Basingstoke and Deane, that commences at Point A on the map and proceeds generally north-westwards before curving north-eastwards to a junction with Footpath 15 at Point B, then north-eastwards for approximately 28 metres to re-join Bridleway 26 at Point C.

A total length of 213 metres.


