Thank you for your email of 13 November requesting the following information:

- What criteria do soldiers need to meet in order to be eligible to apply to transfer from their cap badge to the Queen Alexandra's Royal Army Nursing Corps (QARANC)?
- For each year over the period 2012 2016 how many vacancies within the QARANC were advertised on the Official Army Vacancy List (OVAL)?
- For each year over the period 2012 2016 how many soldiers by cap badge applied to transfer to the QARANC and of these how many were successful?

Q1. What criteria do soldiers need to meet in order to be eligible to apply to transfer from their cap badge to the Queen Alexandra's Royal Army Nursing Corps (QARANC)?

Eligibility criteria for Soldiers are:

- 1. Medical Employment Standard: MFD
- 2. OPG: B minimum
- 3. Conduct: Exemplary
- 4. Qualifications:
  - a. GCSE: Grade A\*-C in English Lang, Maths and Science.
  - b. Alternatives are excepted for GCSE English and Maths (L2 Qualifications).
  - c. 120 UCAS tariff points (typically BBB) from a maximum of three A/A2 level passes, or equivalent.

Potential candidates are to investigate their eligibility by using the link: http://www.bcu.ac.uk/courses/nursing-adult. All non-UK qualifications will need a NARIC certificate/ confirmation letter

Q2. For each year over the period 2012 – 2016 how many vacancies within the QARANC were advertised on the Official Army Vacancy List (OVAL)?

Q3. For each year over the period 2012 – 2016 how many soldiers by cap badge applied to transfer to the QARANC and of these how many were successful?
