## FOI 760,122 REQUEST FOR '...Highways England's Transport Consultancy contracts...'

I am writing regarding your request for information received on the 23/02/2018.

To ensure value for money, all Highway England contracts are competitively tendered using Public Contract Regulations (2015), with all awards publically available on the UK Government Contract Finder portal. This ensures all contracts are awarded fairly and transparently.

With specific regards to Technical Consultancy, Highways England's primary contract vehicle is the Specialist Professional and Technical Services (SPaTS) framework. The framework was advertised and awarded on 16/2/2016 for a four year period and is due to expire on 15/2/2020.
