## Release of Information

Thank you for your email of 19 February 2018 requesting the following information:

- 1. "% chance of achieving length of service for a new entrant RN General Service (Warfare) rating of rank OR-1.
- 2. % chance of achieving length of service up to the age of 60 for an RN General Service (Warfare) rating of rank OR6 with 27 years LoS
- 3. The number, rank and age of all General Service (Warfare) ratings currently serving on an ES3 engagement.
- 4. Details of any financial incentives for RN General Service (Warfare) ratings to commit to continued service."

I am treating your correspondence as a request for information under the Freedom of Information Act 2000.

A search for the information has now been completed within the Ministry of Defence, and I can confirm that some of the information in scope of your request is held. Information in respect of Questions 1 to 3 of your request can be found at Annex A to this letter. I should explain that information in response to Question 2 is not held in the format required to provide a percentage chance of serving to a specific age. I can, however, provide the chance of reaching each subsequent Length of Service (LOS) beyond 27 years, irrespective of age (Table 2 of the Annex).

On the matter of Question 4 of your request on financial incentives for General Service (Warfare), I can confirm that there are no financial incentives for that Branch.

## **Notes**

Please note that the figures for an OR-6 General Service (Warfare) with a LOS of 27 years may be misleading due to the small size of the group in the source data.

Expected LOS in Table 1 is calculated by using the averages of historic data and represents full years of completed service.

Averages are produced using the time period 1 April 2010 – 31 March 2017.

Exiting denotes anything that results in an ending of Regular service, eg time expiry, voluntary outflow, death etc.

Figures have been rounded to the nearest 10, with figures ending in 5 rounded to the nearest 20 to avoid bias. Due
to rounding, totals may not equal the sum of their parts.
