

Dear ,

Thank you for your email of 21 February 2018 requesting the following information:

*"I would like to request some information on your current staff who are in receipt of Recruitment and Retention Allowances (RRAs).*

*I would like to know the number of staff that are currently receiving RRAs in comparison to the full staff numbers (both full and part time). I would also like this broken down by:*

*Department/team*

*The level of remuneration e.g. £10,000 or £6,0000 etc."*

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the UKHO, and I can confirm that all the information in scope of your request is held. The information you have requested can be found below at annex A.

If you are not satisfied with this response or you wish to complain about any aspect of the handling of your request, then you should contact me in the first instance. If informal resolution is not possible and you are still dissatisfied then you may apply for an independent internal review by contacting the Information Rights Compliance team, Ground Floor, MOD Main Building, Whitehall, SW1A 2HB (e-mail [CIO-FOI-IR@mod.uk](mailto:CIO-FOI-IR@mod.uk)). Please note that any request for an internal review must be made within 40 working days of the date on which the attempt to reach informal resolution has come to an end.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
