Dear [Redacted],

Thank you for your e-mail of 26 June, following on from your requesting FOI request dated 18 April, requesting clarification on the information provided in our response dated 22 June 2017.

In the MoD, all financial transactions are logged against Resource Account Codes (RACs). However, as was explained in the previous letter legal costs are not held centrally, but are handled by each individual branch. In order to provide the breakdown of all legal costs as requested, we selected all expenditure within the 3 specified date ranges for the 3 RACs that cover legal costs. Hence, in order to provide the answer to your question, any company which had transactions recorded against it under these codes were included, regardless of the type of company they are.

It is possible that the transactions logged against the sorts of companies you refer to in your e-mail (Jacobs, SAAB, BAE etc.) were mis-booked against the legal RACs, and we did acknowledge this in the response to question 2 when we were explaining the difference between the total costs provided by us and the published Annual Report and Accounts (ARAc). Unfortunately, there is no way we could identify whether a cost has been mis-booked or whether it was a valid 'legal' transaction from the RAC data and could not do so without contacting every branch in the MoD to get their transaction information for legal costs. This would, obviously, be prohibitively expensive both in terms of cost and time spent collecting the information.

If we remove the transactions for all but the recognisably legal firms, we get the following figures for the overall total legal expenditure:

If you are not satisfied with this response or you wish to complain about any aspect of the handling of your request, then you should contact me in the first instance. If informal resolution is not possible and you are still dissatisfied then you may apply for an independent internal review by contacting the Information Rights Compliance team, Ground Floor, MOD Main Building, Whitehall, SW1A 2HB (e-mail CIO-FOI-IR@mod.uk). Please note that any request for an internal review must be made within 40 working days of the date on which the attempt to reach informal resolution has come to an end.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
