I am writing in response to your request for information regarding the below. Your request has been handled under Section 1(1) of the Freedom of Information Act 2000. In accordance with Section 1(1) (a) of the Act I hereby confirm that the CNC/CNPA does not hold information of the type specified. The answer to all of the below are zero.

**Please can you tell me the number of arrests that have been made in the last 12-months (July 2016 - 2017), as a result of Dark Justice tip offs (an anonymous group who have been catching online predators who target children since 2014), please? How many of those arrested were later charged- please break this down by age and gender. What were the charges? What were the ages of the children involved?**

**Can you also tell me how many arrests, without tip offs from Dark Justice, have been made on individuals wanting to meet up with children under the age of 16, where they have been approached online, in the last 12 months (July 2016 -2017), please? How many of these arrests have resulted in charges- what were the charges? Please break those arrested and charged down by age and gender. Thank you.**

**How many members of Dark Justice have been arrested and what were they arrested for, in the last 12-months (July 2017 - 2017), please? How many were later charged and what where they charged for?**

The Civil Nuclear Constabulary is a specialist armed police service dedicated to the civil nuclear industry, with Operational Policing Units based at 10 civil nuclear sites in England and Scotland and over 1400 police officers and staff. The Constabulary headquarters is at Culham in Oxfordshire. The civil nuclear industry forms part of the UK's critical national infrastructure and the role of the Constabulary contribute to the overall framework of national security.

The purpose of the Constabulary is to protect licensed civil nuclear sites and to safeguard nuclear material in transit. The Constabulary works in partnership with the appropriate Home Office Police Force or Police Scotland at each site. Policing services required at each site are agreed with nuclear operators in accordance with the Nuclear Industries Security Regulations 2003 and ratified by the UK regulator, the Office for Nuclear Regulation (ONR). Armed policing

services are required at most civil nuclear sites in the United Kingdom. The majority of officers in the Constabulary are Authorised Firearms Officers.

The Constabulary is recognised by the National Police Chiefs' Council (NPCC) and the Association of Chief Police Officers in Scotland (ACPOS). Through the National Coordinated Policing Protocol, the Constabulary has established memorandums of understanding with the local police forces at all 10 Operational Policing Units. Mutual support and assistance enable the Constabulary to maintain focus on its core role.

We take our responsibilities under the Freedom of Information Act seriously but, if you feel your request has not been properly handled or you are otherwise dissatisfied with the outcome of your request, you have the right to complain. We will investigate the matter and endeavour to reply within 3 – 6 weeks. You should write in the first instance to:
