WILDLIFE AND COUNTRYSIDE ACT 1981

London Borough Of Hillingdon
Definitive Map Modification Order to add a Public Footpath in
the Eastcote and East Ruislip Ward
Definitive Map Modification Order 2017 No. 3

Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Order.

The **start date** for the above Order is **17 April 2018**.

Consideration of the Order will take the form of a public local inquiry.

The Inquiry will be held at **Committee Room 6, Civic Centre, High Street, Uxbridge, Middlesex, UB8 1UW** on **Wednesday 31 October 2018** at 10.00am.

The effect of the Order, if confirmed without modifications, will be to modify the definitive map and statement for the area by adding a footpath commencing in Azalea Walk at TQ 5106 1883 point A on the Order plan and continuing in a southerly direction to turn eastwards with a width of 2 metres and then in a southerly direction with a width of 1 metre to terminate through a metal gate onto the public footpath R154 at TQ 5106 1883, point B on the Order plan.

Timetable for sending in statements of case and proofs of evidence

Within 8 weeks of the start date by [by 12 June 2018]

The Order Making Authority must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the

Secretary of State will send a copy (excluding copies of any supporting documents - these will be available to view at the Authority's offices) to everyone who has made an objection or representation and the applicant and any other person who has written to us in respect of the Order.

Within 14 weeks of the start date [by 24 July 2018]

Everyone who has made an objection or representation and anyone who wishes to give evidence at the Inquiry must ensure their statement of case¹ is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send full copies to the Authority. Copies will also be sent to the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Order (excluding copies of any supporting documents - these will be available to view at the Authority's offices).

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a full copy to the Authority. Copies will also be sent to everyone who has made an objection or representation and any other person who has written to us in respect of the Order (excluding copies of any supporting documents - these will be available to view at the Authority's offices).

4 weeks before the date of the inquiry [by 03 October 2018]

The Authority, everyone who has made an objection or representation, the applicant (if applicable) and anyone who wishes to give evidence at the Inquiry must ensure their proof of evidence (together with any summary) is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of:

- i) the Authority's proof of evidence to everyone who has made an objection or representation, the applicant and anyone who has submitted a statement of case (excluding copies of any supporting documents - although none should be submitted with a proof of evidence);
- ii) the applicant's proof of evidence to the Authority, everyone who has made an objection or representation and anyone else who has submitted a statement of case (excluding copies of any supporting documents - although none should be submitted with a proof of evidence); and
- iii) all other proofs of evidence to the Authority, the applicant, everyone who has made an objection or representation and anyone else who has submitted a statement of case (excluding copies of any

supporting documents – although none should be submitted with a proof of evidence).

All parties must keep to the timetable set out above and ensure that statements of case and proofs of evidence are received by the Secretary of State on time. Late documents will be returned.

DEFINITIVE MAP MODIFICATION ORDER 2017 NO 3

This Order is made by London Borough of Hillingdon ('the Authority') under Section 53 (2) (a) of the Wildlife and Countryside Act 1981 ('the Act') because it appears to the Authority that the Definitive Map and Statement for London Borough of Hillingdon requires modification in consequence of the occurrence of an event specified in section 53 (3).(c) (i) of the Act, namely the discovery of evidence of a hitherto unrecorded right of way.

This Authority is the only local authority whose area includes the land to which the Order relates. The London Borough of Hillingdon hereby order that:

1. For the purposes of this Order the relevant date is 5 October 2017.
2. The Definitive Map and Statement of the London Borough of Hillingdon shall be modified as described in Part I of the Schedule and shown on the plan attached to this Order.
3. This Order shall take effect on the date it is confirmed and may be cited as the London Borough of Hillingdon Definitive Map Modification Order 2017 No 3.

Description of path to be added

A footpath commencing from Azalea Walk at TQ 5106 1883, between the properties known as No.47 and No.43, point A on the Order plan and continuing in a southerly direction to turn eastwards with a width of 2 metres and then in a southerly direction with a width of 1 metre to terminate through a metal gate onto public footpath R154 at TQ 5106 1883, point B on the Order plan. This is a total length of 55 metres with a varying width of 1 and 2 metres. The route of the path is shown coloured purple on the attached plan.

A footpath commencing from Azalea Walk at TQ 5106 1883, between the properties known as No.47 and No.43, continuing in a southerly direction to turn eastwards with a width of 2 metres and then in a southerly direction with a width of 1 metre to terminate through a metal gate onto public footpath R154 at TQ 5106 1883. 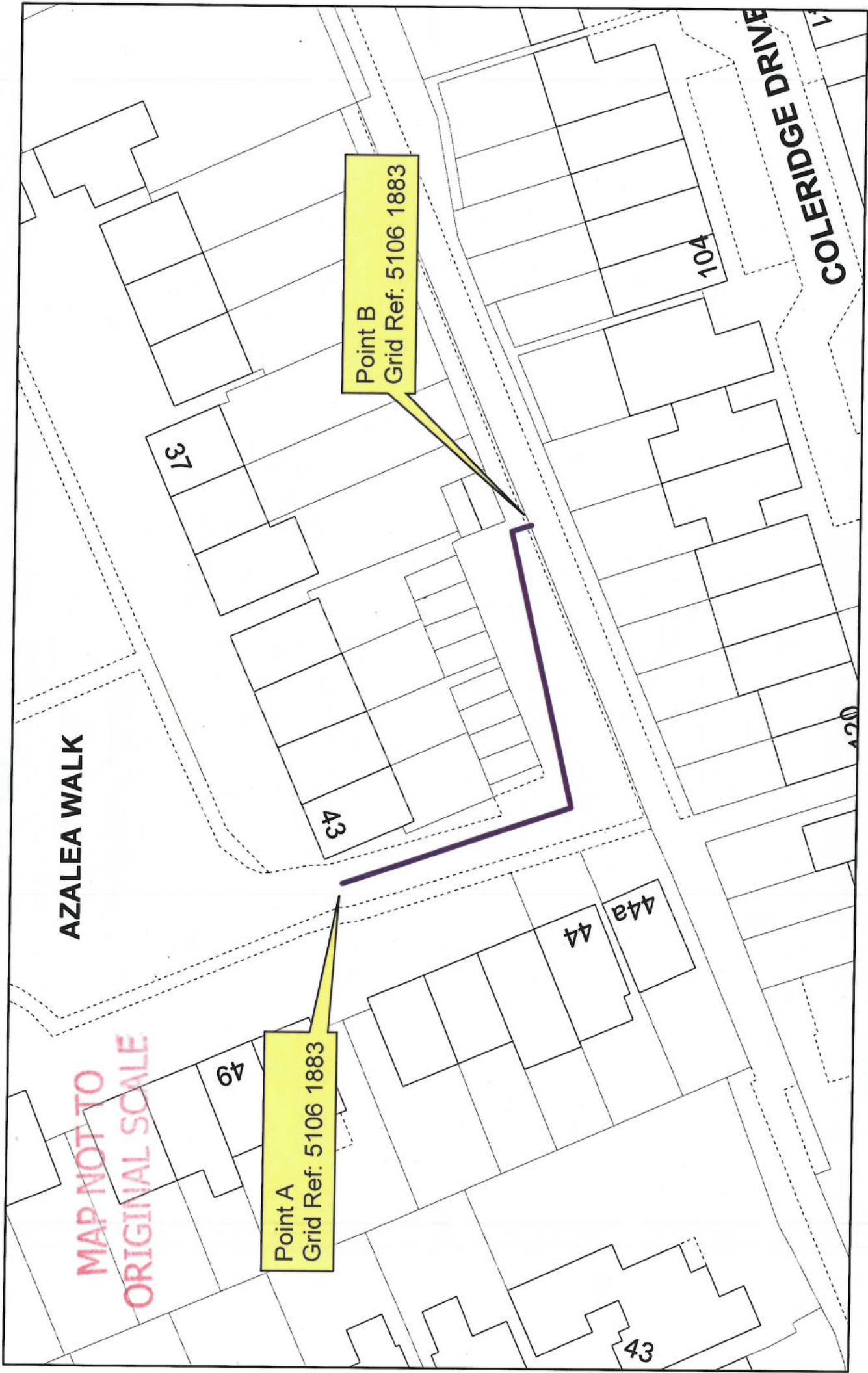
