(Collectively "the Respondents")

UPON the Parties having agreed to the terms set out in the attached Schedule 1, the Judgment of the Employment Tribunal is that:

Union Recognition

- 1. The Parties agree that Unite was recognised by LS Doors for the purpose of collective bargaining under section 178 of the Trade Union and Labour Relations (Consolidation) Act 1992 ("TULR(C)A") in respect of the following bargaining unit: "manufacturing operatives based at Langley Mill"; including specifically the Claimants listed at Schedule 2. The Claimants listed at Schedule 2 have brought claims relying both on section 189(1)(a) and 189(1)(c) of TULR(C)A. The Claimants listed at Schedules 3 and 4 have brought claims pursuant to section 189(1)(a) of TULR(C)A.
- 2. The Parties agree that no other trade union was recognised by LS Doors, or L Interiors.

The protective award claims

- 2. In respect of the claims against **LS Doors**, the Parties agree that:
 - 2.1 Pursuant to section 189(1)(c) TULRCA Unite is the only entity with the right to bring claims

for a protective award in respect of the Claimants formerly employed by LS Doors as manufacturing operatives based at Langley Mill, listed at Schedule 2. The Claimants at Schedule 2 therefore withdraw their protective award claims in their individual capacities, brought pursuant to section 189(1)(a) TULRCA.

- 2.2 The Claimants listed at Schedule 3 have correctly brought their claims pursuant to section 189(1)(a) TULRCA.
- 2.3 LS Doors failed to comply with all requirements of section 188 TULR(C)A, as detailed in Schedule 1. In accordance with section 189(2) of TULR(C)A, the Tribunal therefore

- makes a declaration that the complaints are well founded and the Tribunal also makes a protective award.
- 2.4 The protective award made pursuant to section 189(2) TULRCA shall, for the purposes of

section 189(3) TULR(C)A, be made in respect of the following descriptions of employees:

- 2.4.1 Manufacturing operatives based at Langley Mill (Nottingham) who were dismissed as redundant from and including 30 December 2015 and who are listed at Schedule 2:
- 2.4.2 All other employees based at Langley Mill (Nottingham) who were dismissed as redundant from and including 30 December 2015 and who are listed at Schedule 3;
- 2.4.3 All employees based at Mansfield who were dismissed as redundant from and including 30 December 2015 and who are listed at Schedule 3; and
- 2.4.4 All employees based at Barnstaple, Gateshead and Willenhall (which constituted one establishment) who were dismissed as redundant from and including 30 December 2015 and who are listed at Schedule 3.
- 2.5 For the purposes of section 189(4)(a) TULR(C)A, the protected period began on 30 December 2015, which was the date on which the first of the dismissals to which the complaint related took effect;
- 2.6 For the purposes of section 189(4)(b) TULR(C)A, the Tribunal determines that the length of

the protected period is 56 days (8 weeks).

- 2.7 Pursuant to section 190 TULR(C)A, LS Doors is ordered to pay a protective award of 56
- days' (8 weeks') gross pay to the Claimants listed at Schedules 2 and 3.
- In respect of the claims against L Interiors, the Parties agree that, pursuant to section 189 TULR(C)A:
 - 3.1 The Claimants listed at Schedule 4 have correctly brought their claims pursuant to section 189(1)(a) TULRCA.
 - 3.2 L Interiors failed to comply with all requirements of section 188 TULR(C)A, as detailed in Schedule 1. In accordance with section 189(2) of TULR(C)A, the Tribunal therefore makes a declaration that the complaints are well founded and the Tribunal also makes a protective award.
 - 3.3 The protective award made pursuant to section 189(2) TULRCA shall, for the purposes of

section 189(3) TULR(C)A, be made in respect of the following descriptions of employees: all employees employed by L Interiors and dismissed as redundant from and including 30 December 2015 and who are listed at Schedule 4.

- 3.4 For the purposes of section 189(4)(a) TULR(C)A, the protected period began on 30 December 2015, which was the date on which the first of the dismissals to which the complaint related took effect;
- 3.5 For the purposes of section 189(4)(b) TULR(C)A, the Tribunal determines that the length of

the protected period is 35 days (5 weeks).

3.6 Pursuant to section 190 TULR(C)A, LS Doors is ordered to pay a protective award of 5

weeks' gross pay to the Claimants listed at Schedule 4.

4. For the avoidance of doubt the award relates solely to those employees listed at Schedules 2. 3 and 4.

Other claims

- 5. In respect of all claims against LS Doors and L Interiors, all claims (save for the protective award claims above) are hereby dismissed upon withdrawal. For the avoidance of doubt, this includes (but is not limited to) claims in relation to:
 - 5.1 Unfair dismissal;
 - the Transfer of Undertakings (Protection of Employment) Regulations 2006;
 - 5.3 Redundancy payment;
 - 5.4 Notice pay;
 - 5.5 Holiday pay;
 - 5.6 Arrears of pay;
 - 5.7 Breach of contract;
 - 5.8 Other payments.
- 6. All claims against IDSL, UFDL and the Secretary of State are dismissed upon withdrawal.

Costs

7. There shall be no order requiring any party to pay or reimburse another party's costs or for the Respondents to reimburse any of the Claimants' fees. However, nothing within this Order shall prevent any Claimant from applying to the Ministry of Justice for repayment of any Employment Tribunal fees paid.

The Parties have agreed as follows:

This Agreement relates only to the former employees of LS Doors as set out at Schedule 2 and Schedule 3 and the former employees of L Interiors as set out at Schedule 4.

SCHEDULE 1

- The claims listed below shall be referred to in this Agreement as "the Claims", and are the only claims which have been brought by the Claimants:
 - 2.1 Protective award;
 - 2.2 Unfair dismissal;
 - 2.3 Claims in relation to the Transfer of Undertakings (Protection of Employment) Regulations 2006;
 - 2.4 Redundancy payment;
 - 2.5 Notice pay;
 - 2.6 Holiday pay;
 - 2.7 Arrears of pay;
 - 2.8 Breach of contract;

2.9 Other payments

LS Doors

- 3 LS Doors proposed to dismiss as redundant 20 or more employees at each of the following three establishments:
 - 3.1 Langley Mill (Nottingham);
 - 3.2 Mansfield; and
 - 3.3 Barnstaple, Gateshead and Willenhall (which constituted one establishment).
- The redundancies were proposed to take place within a period of 90 days or less. LS Doors was therefore under a duty to consult appropriate representatives, pursuant to section 188 (1B) of the Trade Union and Labour Relations (Consolidation) Act 1992. In respect of the employees based at Langley Mill a number of the employees (including those listed at Schedule 2) were of a description of which an independent trade union (Unite) was recognised. In relation to those employees, LS Doors was therefore under a duty to consult with Unite, and did so.
- In relation to the Claimants listed at Schedule 3, LS Doors was under a duty to consult with employee representatives elected by the affected employees, in an election satisfying the requirements of section 188A(1) of the Trade Union and Labour Relations (Consolidation) Act 1992.
- 6 LS Doors was placed into administration on 18 December 2015.
- The parties agree that LS Doors undertook a limited collective consultation with Unite and employee representatives which was not fully compliant with the requirements of the Trade Union and Labour Relations (Consolidation) Act 1992.
- 8 The parties further agree that:
 - 8.1 Consultation did not begin at least 30 days before the first of the dismissals took effect on 30 December 2015, contrary to section 188 (1A) of the Trade Union and Labour Relations (Consolidation) Act 1992.
 - 8.2 The requirements for the election of employee representatives under section 188A were not fully complied with. Therefore, the Claimants set out at Schedule 3 are entitled to claim a protective award in their own capacity, pursuant to section 189 (1) (a).
- 9 Given the circumstances, including the financial situation of LS Doors, the protective award is by consent determined to be 8 weeks' gross pay in respect of those Claimants set out at Schedules 2 and 3.

L Interiors

- L Interiors proposed to dismiss as redundant a number of employees at one establishment within a period of 90 days or less. It cannot be determined whether the number was fewer than 20 (as stated by L Interiors) or 20 or more (as stated by the Claimants at Schedule 4). In the event that the Claimants are correct, L Interiors was under a duty to consult appropriate representatives, pursuant to section 188 (1B) of the Trade Union and Labour Relations (Consolidation) Act 1992.
- 11 L Interiors was placed into administration on 18 December 2015.
- In the event that the Claimants are correct, L Interiors was under a duty to consult with employee representatives elected by the affected employees, in an election satisfying the requirements of section 188A(1) of the Trade Union and Labour Relations (Consolidation) Act 1992.
- The parties do not agree upon whether L Interiors was under such a duty. However, the parties agree that L Interiors did in fact undertake a limited collective consultation with employee representatives which was not fully compliant with the requirements of the Trade Union and Labour Relations (Consolidation) Act 1992.
- 14 The parties further agree that:
 - 14.1 Consultation did not begin at least 30 days before the first of the dismissals took effect on 30 December 2015, contrary to section 188 (1A) of the Trade Union and Labour Relations (Consolidation) Act 1992 (if it so applied).
 - 14.2 The requirements for the election of employee representatives under section 188A (if it so applied) were not fully complied with. The Claimants set out at Schedule 4 are entitled to claim a protective award in their own capacity, pursuant to section 189 (1) (a).
- Given the circumstances, including the financial situation of L Interiors, a protective award is ordered and the award is by consent determined to be 5 weeks' gross pay in respect of those Claimants set out at Schedule 4.

Agreement

Unite and the Claimants listed at Schedules 2, 3 and 4 accept the terms of this Agreement in full and final settlement of all legal proceedings, including but not limited to the specific matters raised in the Claims, and all other claims and rights of action (whether under contract, statute, common law, European law or otherwise) whether known or unknown to the parties, whether or not existing in fact or law, and whether or not they are or could be in the contemplation of the parties at the time of this Agreement, that the Claimants have now or may have in the future against the Respondents and / or their pension trustees, Joint Administrators and their staff,

directors, officers and employees (past and present) (the "Protected Parties") arising directly or indirectly from the Claimants' employment with LS Doors or its termination or otherwise.

- This Agreement shall not apply to any claims which the Claimants may have for personal injury and / or accrued pension rights provided that each Claimant warrants that he / she is currently unaware of any circumstances and ought not reasonably to be aware of any circumstances that could give rise to a personal injury claim against the Respondents or any of the Protected Parties.
- In entering into this Agreement, the Joint Administrators of LS Doors and L Interiors are acting as agent for or on behalf of LS Doors and L Interiors and neither they, their firm, members, partners, employees, advisers, representatives or agents shall incur any personal liability whatever in respect of any of the obligations of LS Doors and / or L Interiors or in respect of any failure on the part of LS Doors and / or L Interiors to observe, perform or comply with any such obligations or under or in relation to any associated arrangements or negotiations or under any other document or assurance.
- 19 For avoidance of doubt, nothing in this Agreement or Consent Order shall render the Joint Administrators of LS Doors and / or L Interiors liable to make any payment to any of the Claimants in respect of the Claims or otherwise as an expense of the administration.
- 20 Unite and the Claimants listed at Schedules 2, 3 and 4 warrant and undertake that he / she shall not, whether directly or indirectly, make, publish or otherwise communicate any disparaging, derogatory or critical statements, whether in writing or otherwise, concerning the Respondents or the Protected Parties.
- Unite and the Claimants listed at Schedule 2, 3 and 4 warrant and undertake that he / she shall not make, whether directly or indirectly, any statement or comment to the press or other media concerning the Respondents or the Protected Parties or his / her employment with LS Doors or L Interiors or its termination or details of the Claims or this Agreement or the Consent Order without the prior written consent of the Administrators (who shall not unreasonably withhold such consent).
- This Agreement constitutes the entire agreement between the parties and supersedes all previous agreements, arrangements and understandings between them relating to the Claimants' employment and its termination. In entering into this Agreement no party has relied on, either wholly or partly, or been induced to enter into this Agreement by any statement, representation, assurance or warranty made by or on behalf of another party (whether orally or in writing) other than as expressly set out in this Agreement. Other than in respect of fraudulent misrepresentation or their own wilful default, no party will be liable to another (in equity, contract or tort, under the Misrepresentation Act 1967 or in any other way) for a representation that is not expressly set out in this Agreement.
