The works are expected to account for approximately £300m over 4-6 years. Under the contract, CSJV will deliver a range of activities. These include utility diversions, ecology surveys, demolition, ground remediation, watercourse activities, highways realignments, monitoring and instrumentation, structural reinforcements, archaeology and site clearance, as well as establishing site compounds.

Works undertaken to date have included; design and build of new ecological sites, ground remediation, advanced landscape planting. In addition surveys have been a large percent of this work, both nonintrusive and intrusive surveys, ranging from environmental, ecology, soil and ground investigation, demolition and archaeology. Additionally, the archaeological programme is expected to be the largest ever undertaken in the history of Britain.

For the future, typical activities to deliver within this contract, currently include; highway design and build schemes, woodland habitat creation, watercourse activities, utility diversions, site clearance and establishing site compounds.

To aid us in our project delivery, we are interested in engaging and working with specialist service providers, within these areas.

Align is a joint venture of three international and privately-owned infrastructure companies; Bouygues Travaux Publics, a subsidiary of Bouygues Construction, Sir Robert McAlpine, and VolkerFitzpatrick, a subsidiary of VolkerWessels. C1 Package

In July 2017, the ALIGN consortium, won the significant C1 package of the UK High Speed 2 line (HS2). Lot C1 consists of 21.6km of high speed rail infrastructure in a rural environment. This will include a 3.37km viaduct, 15.75km twin-tubes tunnel and five vent shafts handling both piston effect and tunnel ventilation.

Until the end of 2018, the team will be working on the development of the scheme design.



Stage two will commence in early 2019 and run until 2023, and will comprise the design and build of C1. The integrated design team, known as Align-D, have now completed the mobilisation phase of the scheme design.

Working with design partners Jacobs and Ingerop, the Align-D team are now in the process of developing the Stage one scheme design.

Key Figures

The three main ALIGN companies collectively employ over 20,000 people and have a combined parentgroup turnover of over £12.5bn. As experienced contractors in the delivery of transport infrastructure, including current high-speed rail projects in the UK, France and Hong Kong, they are able to manage complex projects from inception to completion.
