- (b) a satisfactory system of control over transactions has not been maintained by the union in accordance with the requirements of the legislation,
- (c) the income and expenditure account to which our report relates, and the balance sheet are not in agreement with the books of account of the union,
- (d) we have not obtained all the information and explanations necessary for the purposes of our audit.
