PD TEESPORT'S APPLICATION UNDER ARTICLE 6 OF THE TEESPORT HARBOUR REVISION ORDER 2008 FOR A TEN YEAR EXTENSION TO THE PERIOD FOR COMPLETION OF THE WORKS

The Marine Management Organisation ("MMO") has carried out an Environmental Impact Assessment ("EIA") under the Marine Works (EIA) Regulations 2007 (as amended) ("the MWRs") in relation to the extension to the period for completion of works authorised by the Teesport Harbour Revision Order 2008 ("the Order"). The works constitute a deep sea container terminal at the River Tees, Redcar and comprise capital dredging, construction of a new quay wall, reclamation and the disposal of dredged material.

In accordance with Regulation 22 of the MWRs, the MMO has decided to grant EIA consent for the project on 01 May 2018.
