He is happy for you not to be on the dip passport as you wouldn't have accreditation, however the visa is a must if you can get it. He is currently contacting his counterpart in the Venezuelan consulate in London to seek advice and speed this through.

We're looking forward to seeing you here. As [Redacted] says below, it is better that you come in on a visa. In the past, we have been able to obtain these quickly and painlessly from the Venezuelan Embassy in London. I have written to my opposite number there to say that you are likely to be applying on 27 March (which I understand is when you will be back in London) and asking for confirmation of the type of visa you should apply for (diplomatic or business) and that the visa should be ready by 31 March. If you are able to, I recommend that you submit the visa with your diplomatic passport; but if this is difficult your ordinary passport (with the stamp that I have seen mentioning that you work for HM Diplomatic Service) should be sufficient.

Subject: Venezuelan interest in collaboration with UK on climate issues

### Dear [Redacted]

You may remember being extraordinarily kind and supportive to me when I was charged with putting together the FCO Climate Change Adaptation Plan at rather short notice some years ago. As you can see, I have now been appointed [Redacted]; it may not require too much of a leap of imagination to spot that I'm writing to ask for advice and possible help once again.

In brief, the Venezuelan Ministry of Ecosocialism, the newly-formed lead Ministry for Climate Change, which is tasked with producing their INDC, has expressed interest in collaborating with the UK in a number of possible climate-related areas, including meteorological disaster early warning.

I believe this isn't the first approach the Venezuelans have made. I understand that in my predecessor's time, an attempt at Met office to Met office collaboration progressed to the point where a UK delegation was preparing to visit Caracas, but the necessary political clearances apparently failed to materialise and the visit was called off. [Redacted]

But I hope that, given Venezuela's significance as a fossil carbon reservoir, as custodian of a significant part of the Amazon-Orinoco forest, as owner of the Caribbean's longest coastline, and as a developing country with a [Redacted] audible voice in the region and the wider South, consideration could be given to at least exploring the possibility of a reboot.

For me, the key difference this time is that the approach is coming from the political level so has passed necessary approval hoops. And is being led by Rocio Maneiro, the Venezuelan Ambassador in London, an experienced bureaucrat, [Redacted] and who is working closely with me on a number of initiatives to thicken bilateral relations.

When Rocio approached me for advice on this, I suggested that she seek an initial meeting in the FCO with Sir David King, whom she met when he visited Caracas last autumn, to give her a sense of the UK's broad interests and capabilities; to which Sir David has kindly agreed. But it would obviously be very helpful if we could also indicate that the Met Office would be open to an exploratory meeting. And to give her a contact with whom she could follow up.

I hope this makes sense; do let me know if there is any more background you would like If helpful I could easily phone one afternoon to amplify.

Thanks for your enquiry below. Whilst UK citizens may enter Venezuela without a visa, the Embassy suggests that official visitors do get a visa. Since Sir Ciaran Devane is an HMG official visitor, either the British Council Travel Centre (assuming there is one!) or the FCO Travel Centre should be able to advise on the process and apply for the visa. I am copying to [Redacted]

[Redacted]: the CEO of the British Council, Sir Ciaran Devane, is due to make an official visit to Venezuela in early October, and I'd like to help him and his team apply for visas (he will be staying at the Residence). [Redacted] grateful if you could advise whether they can use the FCO Travel Centre or whether there is an alternative route. From Caracas, we can tip off the Venezuelan Embassy to expect the visa requests; as far as I know, there is no need for a formal letter, but if necessary we can do one here or you can in London.

Unfortunately Maneiro was unwell last week, however her Minister Counsellor (Alfonso D'Santiago) visited the Met Office and met with [Redacted].

The meeting included a great deal of discussion about Met Office weather and climate capabilities, and Mr D'Santiago shared a selection of areas where the Venezuelan national meteorological service would be interested in developing more collaboration with the Met Office.

Mr D'Santiago took an action to work with the ambassador on a letter to the Met Office outlining more clearly possible areas for collaboration. We will then review this to identify where we can practically provide support. In order to set up any formal partnership there would probably then be a technical meeting between the Met Office and INAMEH to discuss capabilities and requirements.
