# Summary

Within the local area of the proposed UTC, it is expected that only three schools may feel a high impact, eight may feel a moderate impact and three schools may feel a minimal impact.

The three schools that may feel a high impact are: Fir Vale School Academy Trust; Sheffield Springs Academy; and Chaucer School. Fir Vale is the closest school (1.1 miles). The school's attainment (37%) is below the national average of 56% and is judged 'Requires Improvement' by Ofsted. The school does not have a sixth form. Sheffield Springs is 2.8 miles from the proposed UTC. It also has a low attainment rate (36%) and is judgeded 'Requires Improvement' by Ofsted. Chaucer School is 3.2 miles away. It has a very low attainment (29%) and is also judged 'Requires Improvement' by Ofsted. Both Sheffield Springs and Chaucer schools have a sixth form.

### Summary

It is expected that the three colleges within the local area of the proposed UTC may feel a moderate impact and two will feel a minimal impact. There is no data available for Chapeltown Academy.

### Conclusion

Overall, the unique nature of the UTC means it will be relatively small in comparison to existing providers and given the large catchment area, the UTC should not attract large numbers of students from any one school. The LA acknowledges there will be an impact on local 11-16 and 11-18 schools in the area however it is supportive of the establishment of the UTC and welcomes the prospect of broadening local educational opportunities for young people and meeting the future skills needs of local businesses. In the light of the evidence available, officials see no reason why the Secretary of State should not enter into a Supplemental Funding Agreement with the academy trust as a result of negative impact.
