



# LINK CASES

#### LINK CASES

DCS can link cases together. This allows for quick navigation between multiple cases using the **Linked Cases** screen. It also provides an option in the **Search** screen to search across the entire chain of linked cases in addition to the current case.



The link function was previously used to chain together the various DCS cases required to set up a multi-handed case.

With the Multi-Hander release of DCS, only one file is required making the link function redundant. It is still available for backwards compatibility.

#### LINKING CASES

Click on the Linked Cases button at the top to link another case.

If the case has already been linked to other cases, they will also be listed.

If the case is not linked, either create a group of linked cases or link the case to an existing group of linked cases.

To create a new group of linked cases:

- 1. Click Create
- 2. Give the group an appropriate name.
- 3. Click 'Go'

The group has now been created.

To link a Case to a group:

- 1. Click View Case List
- 2. Click Update Case on one of the other cases in the list
- 3. Click Linked Cases
- 4. Click Add
- 5. When presented with a list of all Linked Cases Groups, choose the group to add the case to and click Add to Group.

To move from one linked case to another, go to the Linked Cases area and click Go To Case.
