<ul> <li>are destitute or likely to become destitute within 14 calendar days, for guidance on assessing destitution see related link.</li> </ul>
The social services department must state:
when the support they provide will end, and
<ul> <li>if there are any resources available to the applicant which the Home Office needs to consider or which may disqualify the UASC from receiving section 95 support.</li> </ul>
You must ask for these details from the social services department if they do not provide
them.

Age disputes	This period may include the date of the annual change to the section 95 support rates. In this case the under or over payment will have two component rates.


