On Antarctic marine protection generally, we are world leaders – we led the designation of the first ever Southern Ocean MPA, at the South Orkney Islands in 2009; strongly supported the 2016 Ross Sea region MPA; have secured agreement to protect marine areas newly exposed from iceshelf retreat; and are co-proponents/leading contributors to proposals to establish MPAs in the Antarctic Peninsula, Weddell Sea and East Antarctic.
