Introduction and overview

The Research, Translation and Innovation (RTI) division has been working with PHE centres to strengthen links between public health academics and others across the public health system via research and practice workshops to explore public health research needs and priorities in their local areas.

To date, we held 3 such meetings:

- North West Research and Practice Workshop Manchester 4th October 2016
- East Midlands Research and Practice Workshop Nottingham 13th March 2017
- East of England Research and Practice Workshop Cambridge 3rd October 2017

There are 3 more planned between now and the end of March 2018; in the West Midlands, Yorkshire and Humber and South East regions and discussions are underway with other areas in the hope to cover each of the 9 PHE centres by the end of 18/19 financial year.

These regional workshops have included an overview of research priorities from different stakeholder perspectives; PHE Centre, Local Authority and Clinical Commissioning Groups, along with an opportunity for discussions, workshops and a Dragon's Den session with pump priming funds available to enable local research projects to be further developed.

Each of the workshops has been developed with input from a lead in the PHE Centre, the Head of Academic Public Health Support in the RTI division and an academic or other public health professional colleague(s).

In addition, the RTI division has supported the PHE national teams of the Dental and Oral Health team and Chief Nurses Directorate in creating and supporting meaningful academic networks. Further information about these workshops is available on request and this work will continue in future years.

This is the report for the East of England Research and Practice Workshop; which was developed by Dr Sian Evans, Consultant in Public Health, PHE East of England, Dr Jennifer Yip, Consultant in Healthcare Public Health, PHE East of England, Dr Rosalind Parkes-Ratanshi, Lecturer in Public Health University of Cambridge, Lauren Milden, Public Health Policy Coordinator, Cambridge Institute of Public Health, University of Cambridge, Dr John Ford, NIHR Doctoral Research Fellow, University of East Anglia and Nicola Hodgkiss, Head of Academic Public Health Support, Public Health England.

The Cambridge Institute of Public Health and their Research into Policy Project, through the Regional Academic Public Health Forum, co-hosted this event.

Attendees

There were 82 attendees, made up of academics, public health practitioners and commissioners from the East of England. Appendix 1 shows the list of attendees with their employing organisation.

Research needs and priorities in the region

We heard about research needs and priorities for the region from 3 different perspectives:

- Professor Carol Brayne, Director, Cambridge Institute of Public Health, University of Cambridge
- Professor Jim McManus, Director of Public Health, Hertfordshire County Council
- Dr Fiona Head, Associate Director, Clinical Outcomes and Population Health Strategy, NHS Cambridgeshire and Peterborough CGG

A table at the end of the document gives a summary of the research needs highlighted.

Themes

Reassuringly and perhaps unsurprisingly there were some common themes in the presentations. These are as follows –

- need to make better use of the research infrastructure and relationships that already exist in the region
- research that serves the different communities across the region
- effective and cost effective research
- focus on prevention
- evidence based practice with impact assessments, outcomes and evaluations

Presenters and an overview of content

Professor Bernie Hannigan, Director for Research, Translation and Innovation at PHE opened the event and introduced the day's vision for bringing people together from across the region to explore the PH landscape in East of England and understand more about local research needs. She also introduced the concept of 'ResHubs' which are part of PHE's response to the Health of the Public 2040 report that recommends the development of regional hubs of engagement between practitioners and researchers to integrate health of the public research and health and social care delivery; events such as these research and practice workshops are part of that work.

Dr Jo Broadbent, Deputy Director for Healthcare Public Health and Workforce at Public Health England East of England talked to attendees about the PHE East of England centre's vision for the East of England to become a Centre of Excellence for Translational Research – establishing enhanced integration of research and implementation across Academia and Service sectors.

Dr John Ford, NIHR Research Training Fellow, University of East Anglia gave an overview of the Regional Public Health Academic Forum. The forum aims to provide a network and infrastructure to support academic PH in the region, facilitate knowledge production, exchange and application, foster a culture of collaboration and raise awareness of academic public health.

Mark Avery, Digital Health Lead, Eastern Academic Health Science Network (EAHSN) spoke about the work of the Academic Health Science Network and Digital Innovation Hubs; which are a response to the '4th Industrial Revolution' relating to digital interventions and how they are changing health and care and the use of Big Data. He highlighted that the ambition of the EAHSN is for the East of England to be the most hyper connected, data enabled, research ready region in the UK and the work that was underway to help make this happen including the setup of an East of England Health Informatics and Intelligence Partnership.

Dr Christine Hill, Deputy Director, CLAHRC East of England presented a summary of the NIHR Clinical Research Network Eastern. This included the support that was available to researchers via the network and stressed the importance of seeking that support at an early stage to be most effective.

Workshops

We held two workshops on the day for participants to attend. The first workshop concerned accessing PHE data, including background, how to do it and who to speak to. The second was a showcase of local translational public health research which included presentations from:

- Professor Nick Steel, Clinical Professor in Public Health at the University of East Anglia on the Regional Application of Global Burden of Disease
- Dr Tim Ellwell-Sutton, Consultant in Public Health at Thurrock Council on evaluation on smoking cessation.
- Dr Smita Kapadia, Consultant in Communicable Disease Control, South Midlands and Hertfordshire PHE on flu vaccinations.

There was also an honorary contract surgery for anyone with questions relating to honorary contracts with PHE.

Dragon's Den session

As part of the day, we invited researchers to pitch ideas to a panel in a Dragon's Den type exercise. We advertised this opportunity on the event website and asked interested parties to submit an abstract of their proposals. There were 3 pitches made to the panel:

- 1. Monica Scrobotovicui, Thurrock Council: *Pre-appointment checks in Primary Care*
- 2. Liz Cross, Herts Valley CCG: Implementation of CRP near patient testing for lower respiratory tract infections in primary care. A service evaluation of a GP/community pharmacy model
- 3. Eleanor Turner-Moss, Cambridgeshire County Council and Caroline Lee, Cambridge Institute of Public Health: *In search of robust and practical evaluations* frameworks for community organised capacity building and resilience initiatives

The panel was made up of Professor Carol Brayne, Director, Cambridge Institute of Public Health, University of Cambridge, Dr Fiona Head, Associate Director, Clinical Outcomes and Population Health Strategy, NHS Cambridgeshire and Peterborough CGG and Professor Nick Steel, Clinical Professor in Public Health at the University of East Anglia.

The £5,000 prize money was split equally between projects 2 and 3, and recipients will provide a progress report in 12 months' time to PHE's pump priming panel.

Next steps and conclusion

It was clear throughout the day from the different speakers and attendees that there is a great appetite for the region to be an exemplar of good engagement across the sectors and to make better use of the relationships and structures that exist.

There are a number of action points that the East of England centre will take forward:

- Establish East of England Evaluation Network as a quick win and step towards a full regional research hub (Reshub), as recommended in Health of the public to 2040 report.
- 2. Consider how we can create additional capacity for research by looking into new funding routes and joint bids to maximise potential within funding rules
- 3. Work with EAHSN and other partners on both data integration AND system transformation can we take a "context and readiness" approach to support systems with transformation?
- 4. Develop resilient research models that deliver in terms of implementation and robustness for publication seek win-wins around enduring themes eg inequalities
