Thank you for your correspondence of 10th March 2018 requesting the following information:

- "1. How many weapons (by type) and explosive munitions for which the Department has responsibility have been recorded as (a) lost and (b) stolen in 2017.*
- 2. Please provide a list of all stolen items, value and location of the theft of all items that were recorded stolen in the 2017 calendar year.*
- 3. How many department computers, laptops, memory sticks were lost/stolen by month since January 2017?"*

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence, and I can confirm that some of the information in scope of your request is held.

1. How many weapons (by type) and explosive munitions for which the Department has responsibility have been recorded as (a) lost and (b) stolen in 2017.

Source – Directorate of Security & Resilience

The information you have requested can be found below, but some of the information falls entirely within the scope of absolute exemptions provided for at Section 21 (Information reasonably accessible to the applicant) because this information has already been released under a previous FOI reference (FOI2017/07673), a copy of which is attached at Annex A.

In addition to the above for August 2017 onwards, the following have been reported, and remain, missing:

The MOD takes the security of firearms and ammunition very seriously and have robust procedures to deter and prevent losses and thefts which are constantly reviewed. The majority of ammunition losses occur as a result of accidental loss during exercises or on operations.

2. Please provide a list of all stolen items, value and location of the theft of all items that were recorded stolen in the 2017 calendar year.

The MOD works hard to detect and deter theft and there are robust processes in place to raise awareness of the need for vigilance in all aspects of security. Just as theft occurs in wider society, the MOD is not immune and we actively encourage individuals to report any evidence of loss or suspicion of theft. It is important to note that in some cases of reported theft the property is later recovered. In the case of key assets however, MOD sites have a wide range of additional security measures to ensure their safety.

Please note that this response only lists those items where the cases have been closed within the time frame specified and the completed investigations established that items were stolen.

3. How many department computers, laptops, memory sticks were lost/stolen by month since January 2017?

The MOD treats information security as a top priority. All incidents of equipment going missing or stolen are thoroughly investigated and may result in disciplinary action. The MOD promotes a culture where security is the responsibility of all staff and personnel are required to report all security incidents. This can result in figures appearing higher than comparable organisations.

Using the incident types of 'Loss' and 'Theft' the table shows how many computers, laptops, memory sticks have been recorded in the MOD security incident management database as lost/stolen by month since Jan 17

Thank you for your email dated the 1st August 2017 where you have requested the following information:

"Under the FOIA I would like to know the following please:

The amount and type of ammunition, the amount and type of firearms and the amount and type of military equipment that has been reported "missing" for the calendar years 2015, 2016 and 2017 to date.

Please limit your search to what has gone missing from any and all military bases in the following unitary areas: Bristol, South Gloucestershire, Bath & North East Somerset, North Somerset, Somerset, Wiltshire, Gloucestershire and Swindon.

Please break the information down by base and by year (and month if possible)

By "missing" I mean lost and/or stolen: please give details of what happened in each case so far as it is known."

I am treating your correspondence as a request for information under the Freedom of Information Act 2000.

A search for the information has now been completed within the Ministry of Defence, and I can confirm that all the information in scope of your request is held.

The information you have requested regarding the amount and type of ammunition, the amount and type of firearms can be found below, but some of the information falls entirely within the scope of absolute exemptions provided for at Section 21 (Information reasonably accessible to the applicant):

In addition to the above, for 2017, the following have been reported, and remain, missing:

Firearms: None reported missing since April 2017.

Section 31 is a qualified exemption and is subject to public interest testing which means that the information requested can only be withheld if the public interest in doing so outweighs the public interest in disclosure.

Section 31 has been applied because releasing details of weapon thefts/losses, broken down by year, type and specifically where it was taken from could be prejudicial to the prevention and detection of crime. When a public interest test was conducted relating to the use of this section, it was deemed that the balance of public interest lay against the release of location for the aforementioned reasons.

In respect of your question "*Type of military equipment that has been reported "missing" for the calendar years 2015, 2016 and 2017 to date.*" I can confirm that MOD holds information on the subject you have requested. However, I have to advise you that we will not be able to answer your request without exceeding the appropriate limit.

Section 12 of the Act makes provision for public authorities to refuse requests for information where the cost of dealing with them would exceed the appropriate limit, which for central government is set at £600. This represents the estimated cost of one person spending 3.5 working days in determining whether the department holds the information, and locating, retrieving and extracting it.

Section 16 of the FOIA requires a public authority to offer advice and assistance on how to reduce or refine a request to bring the cost of compliance under the limit by narrowing or limiting its scope. The MOD may be able to provide some information in scope of your request if you reduce or refine your request to bring the cost of compliance under the limit. This may be achieved by limiting the timeframe specified in your request; limiting your request to stolen items only; or losses recorded by specific MOD bases/Locations. Please contact the FOI-CIO team if you would like to refine your request or require advice on doing so.

You may also find it helpful to note the MOD records information on losses that occur for a variety of reasons. Stores losses, which relate to losses of items of equipment, etc, are recorded discretely within the Department and are categorised into either culpable losses, including fraud, theft, arson, sabotage, repairable damage to buildings, stores, etc, caused maliciously (known as category B1 losses), and all other types of stores losses (known as category B2 losses). Thefts are a subcategory of category B1 losses and because of the seriousness of the matter we keep separate central records on thefts. For that reason, it is

generally easier to provide information about thefts than other types of losses, though it is dependent on the nature of the specific enquiry.
