Please can you list the reasons given (specific reason or by category, depending on how data is kept) for sick days at the Foreign and Commonwealth Office in 2016 and in 2017 so far (please provide your most up-to-date documents)?

Please can you list how many sick days were taken at the Foreign and Commonwealth Office in the specified time periods for each of the reasons listed?

Please send confirmation of receiving this request, and respond within the guaranteed 20 working day limit.

I am writing to confirm that we have now completed the search for the information which you requested.

I can confirm that the Foreign and Commonwealth Office (FCO) does hold information relevant to your request.

The data below shows sick absence days recorded for FCO UK Based staff from January to December 2016 and 1 January to 30 September 2017. We collate sick absence data on a quarterly basis, which is why data after September 2017 is not yet available.
