EXPORT OF REPTILES FROM THE UNITED KINGDOM TO ISRAEL.

NOTES FOR THE GUIDANCE OF THE OFFICIAL VETERINARIAN AND EXPORTER

IMPORTANT

These notes provide guidance to Official Veterinarians (OV) and exporters. The NFG should have been issued to you together with export certificate 6686EHC. The NFG should not be read as a standalone document but in conjunction with certificate 6686EHC. We strongly suggest that exporters obtain full details of the importing country's requirements from the veterinary authorities in the country concerned, or their representatives in the UK, in advance of each consignment.

1. SCOPE OF THE CERTIFICATE

Export health certificate 6686EHC may be used for the export of reptiles from United Kingdom to Israel.

2. CERTIFICATION BY AN OFFICIAL VETERINARIAN (OV)

This certificate may be signed by an OV appointed by the Department for Environment, Food and Rural Affairs, the Scottish Government or the Welsh Government, who is on the appropriate panel for export purposes or who holds the appropriate Official Controls Qualification (Veterinary)(OCQ(V)) authorisation, or an Authorised Veterinary Inspector (AVI) appointed by the Department of Agriculture, Environment and Rural Affairs - Northern Ireland (DAERA).

 ${\tt OVs/AVIs}$ should sign and stamp the health certificate with the ${\tt OV/AVI}$ stamp in any colour OTHER THAN BLACK.

A certified copy of the completed certificate must be sent to the issuing office (in GB - the Customer Service Centre, Carlisle) within seven days of signing, or in the case of Northern Ireland, to DAERA, Dundonald House, Belfast.

The OV/AVI should keep a copy for his/her own records.

3. CLINICAL EXAMINATION

Paragraph IV (a) refers. The examination must take place within 48 hours of the intended time of export.

4. SALMONELLA TEST

Paragraph IV (b) refers. The test must be conducted within 14 days of export. Note that the sample must be submitted to a laboratory of the Animal and Plant Health Agency (APHA), leaving sufficient time for the result to be obtained before the date of export.

5. C.I.T.E.S

This certificate does not provide exemption from other legislation laid down for the protection or conservation of certain wild species, e.g. the Convention on International Trade in Endangered Species (C.I.T.E.S.). 6. WELFARE

Welfare conditions during transport are laid down by Council Regulation EC 1/2005, implemented in England by The Welfare of Animals (Transport) (England) Order 2006, and parallel legislation in Scotland, Wales, and Northern Ireland.

Exporters must comply with the UK welfare laws relating to the export of animals. If transported by air, animals should be transported in accordance with International Air Transport Association (IATA) standards
