EXPORT OF BENEFICIAL INSECTS (FOR CROP PROTECTION) FROM THE UNITED KINGDOM TO REPUBLIC OF TURKEY

NOTES FOR THE GUIDANCE OF THE OFFICIAL VETERINARIAN AND EXPORTER

#### IMPORTANT

These notes provide guidance to Official Veterinarians (OVs) and exporters. The NFG should have been issued to you together with export certificate 7989EHC. The NFG should not be read as a standalone document but in conjunction with certificate 7989EHC. We strongly suggest that exporters obtain full details of the importing country's requirements from the veterinary authorities in the country concerned, or their representatives in the UK, in advance of each consignment.

#### 1. Scope of the certificate

This certificate may be used to accompany the export of beneficial insects (for crop protection) from the United Kingdom to the Republic of Turkey.

# 2. <u>Certification by an Official Veterinarian (OV)</u>

The OV/AVI should keep a copy for his/her own records. This certificate may be signed by an Official Veterinarian, appointed by the Department for Environment, Food and Rural Affairs (Defra), Scottish Government, Welsh Government, or AVI in the Department of Agriculture, Environment and Rural Affairs Northern Ireland (DAERA), who is an Official Veterinarian (OV) on the appropriate panel for export purposes or who holds the appropriate Official Controls Qualification (Veterinary)(OCQ(V)) authorisation. OVs should apply the OV stamp to the certificate in the normal manner.

The health certificate must be signed and stamped with an OV stamp in any colour OTHER THAN BLACK.

A certified copy of the completed certificate must be sent to the issuing office (in GB, APHA, Centre for International Trade, Carlisle) and in the case of Northern Ireland to DAERA, Room 922 Dundonald House, Belfast, within seven days of signature.

The stamp and signature must be made in ink of any colour other than black.

### 2. Addresses and Transport

Part I refers. The exporter should complete the information required in the sections to be completed, by inserting the

- Region of Origin (county that the exporter is based in).
- Full and address of the Consignor.
- Full and address of the Consignee.
- Address of holding of origin and registration number (this refers to the exporters address and company registration number).
- Means of transport e.g. road/air.

## 3. Identification

Part II refers. The exporter must ensure that the OV is able to identify the insects and mites in the packages and containers containing them by ensuring that the contents are visible to enable the OV to inspect the contents of the containers or packages. The containers and packages must be clearly labelled with the species, scientific name and quantity enclosed in each package or container. For the purposes of this certificate the total number of each species should be entered in the number of animals. The number of packages/containers containing the species to be exported in the consignment could be entered underneath if there are many packages.

## 4. <u>Clinical inspection of health, freedom from clinical signs of</u> infection and fitness to travel

The clinical inspection at Part III (a) does not specify the timeframe in which the consignment should be inspected. The inspection should be arranged between the exporter and Official Veterinarian to be carried out on a date and time convenient to the Official Veterinarian, prior to despatch of the consignment.

If the Official Veterinarian is not familiar with the normal appearance of the species to be exported, they should obtain published photographs for example from the exporter or from a book.

The Official Veterinarian should note that it is important to consider the health of insects and mites for export as a group. The appearance of the insects may vary slightly but the Official Veterinarian should consider first principles of indications of health or disease.

The batch of insects and mites must be assessed as alive - i.e. they must not be assessed as dead or dying. The batch should be reasonably consistent in shape, size and colouration.

Certification of fitness to travel can be provided providing the insects are considered to be clinically healthy.

# 5. **Exporter's declarations**

Part III(b) refers. The OV must obtain a written assurance from the owner/exporter in order to certify this paragraph. The declarations should not be attached to the health certificate, but should be retained by the OV for record purposes.

# 6. Disclaimer

This certificate is provided on the basis of information available at the time and may not necessarily comply fully with the requirements of the importing country. It is the exporter's responsibility to check the certificate against any relevant import permit or any advice provided by the competent authority in the importing country.
