- I, the undersigned, certify that the animals described above meet the following requirements:
- a) the animals have resided permanently in Great Britain for at least the past 2 years or since birth;
- b) the premises of origin at paragraph II (b) above retains the services of a veterinarian on a regular basis for the investigation of any incidents where the presence of an infectious or contagious disease could be suspected;
- no case of rabies has been confirmed at the premises of origin at paragraph II (b) during the past 2 years;

- e) each of the animals for export has been tested by the intra-dermal skin test for **tuberculosis** within the last 30 days prior to shipment with negative results in each case, and a test certificate is attached herewith;
