IV. Health Information

I, the undersigned, certify that the day old chicks described above meet the following requirements:

- a) Great Britain is officially free from **highly pathogenic avian influenza (HPAI)** according to the criteria of the OIE;
- b) vaccination for avian influenza is forbidden in Great Britain in accordance with European Union (EU) legislation;
- c) no outbreak of notifiable **low pathogenic avian influenza (LPAI)** has been confirmed at any of the farms of origin, nor within a radius of 6 kms thereof, within the past 12 months.
- d) the flock of origin has been continuously resident in Great Britain for a period of at least 90 days prior to the export of the day old chicks;
- e) no outbreak of **Newcastle disease** has been confirmed by the Department at the premises of origin or within a radius of 25 kms thereof during the 30 days prior to export;
- f) the flock(s) of origin are subject to routine veterinary supervision and there has been no evidence of the following diseases during the 6 months immediately prior to export:
Newcastle disease, fowl pox, fowl cholera (Pasteurella multocida), fowl typhoid (Salmonella gallinarum), infectious bronchitis (IB), infectious laryngotracheitis (ILT), infectious synovitis, infectious bursal disease (IBD or Gumboro disease), egg drop syndrome (EDS '76), pullorum disease (Salmonella pullorum), typhroid disease, ornithosis, Marek's disease, lymphoid leucosis, mycoplasmosis, chronic respiratory disease (CRD), swollen head syndrome (avian pneumovirus), chick anaemia agent, avian nephritis, leucocytozoonosis, infectious coryza, avian spirochaetosis, avian encephalomyelitis, avian salmonellosis, avian tuberculosis;
- g) the farm(s) of origin are members of the government supervised Poultry Health Scheme and as such are subject to regular official veterinary inspection; In addition, routine inspections of all flocks on the farm(s) of origin are carried out by an authorised veterinary officer.
- h) **EITHER** * (i) on (date), blood samples were taken from a representative sample selected at random from the flock(s) of origin and tested serologically at the Veterinary Laboratory Agency (VLA) for **Salmonella pullorum, S. typhimurium, S. gallinarum and S. enteritidis** with negative results in each case;

OR *(ii) the flocks of origin are subject to regular microbiological sampling at the hatchery at least once per fortnight for **Salmonella enteritidis, S.typhimurium, S.pullorum and S.gallinarum** according to a Government controlled monitoring scheme and have given negative results in each case during the past 6 months;

j) the hatchery is a member of the government supervised Poultry Health Scheme , under which it is obligatory that eggs are sterilised prior to incubation, and that hatchery equipment is sterilised prior to use, and that high standards of biosecurity are maintained;

k) the chicks have not been vaccinated for any disease other than Marek's disease; they were vaccinated against Marek's disease with an authorised vaccine as follows:

l) the flocks of origin have been inspected by the authorised veterinarian and showed no clinical signs of communicable disease on the day of shipment.

m) the chicks have been packed for export in clean, new, unused boxes and separators and no contact with other poultry or day old chicks from other farms.

n) I have received a written declaration from the owner/exporter that the chicks will be transported direct from the hatchery to the airport of departure and will not be allowed to come into contact with any birds or animals of a lower health status;

o) I have this day inspected the chicks for export and found them to be free from any clinical signs of disease, and in my opinion fit for the intended journey.

V. This certificate is valid for 10 days.
